FROM AGRICULTURAL A-1 TO A-2, AGRIBUSINESS

<u>3387A-09 & CU1543-09 – Joe Esther/Mildred Lindholm Country Investments LLC Property:</u> Rezone PIN 016-0514-0822-000 (1.1 Acre) with conditional use to allow for a construction company office and for storage of non-farm equipment, including limited outside storage. The site is at **W6855 STH 106** in the Town of Koshkonong.

FROM AGRICULTURAL A-1 TO A-2, AGRIBUSINESS AND A-3, RURAL RESIDENTIAL

<u>3388A-09, CU1544-09 & 3389A-09 – Leonard & Kathleen Kalvaitis:</u> Rezone approximately 1.3 acre with conditional use for storage of non-farm equipment.
