RE: Inviting your comments as we update Clean Sweep regulations

We are revising ATCP 34, the administrative rule under which we operate the Clean Sweep grant program. To do this, we need your input.

If you are interested in **agricultural and household hazardous waste grants**, attend 9-11:30 a.m. If you are interested in **unwanted prescription drug grants**, attend 1-3 p.m. If this doesn't work for your schedule, please feel free to attend during either time to give us your comments.

Although we welcome all of your comments, we are particularly interested in the issues of application scoring, grant distribution, program definitions and eligible expenses. Some questions we'll ask you to think about:

Grant distribution

- Should the program provide base grants to every applicant or should we maintain Clean Sweep as a competitive grant program?
- What scoring criteria should we use, if any?
- If competitive, should local governments with permanent collection facilities receive preference *or* should rural communities with no collection facilities receive preference?
- Should we offer ag grants every other year?
- Should we change the maximum awards?

Multi-government applications

• What is a better definition for "multi-government"?

Eligible expenses

- Should we allow purchase of drug drop boxes?
- Should we allow volunteers as part of in-kind match?

Once we have gathered your input, we'll draft a revised rule. We anticipate holding public hearings in October, and having the revised rule in place for the 2015 grant cycle.
