# Establishing a partnership with Netwurx Internet, LLC to provide a phase 1 Broadband infrastructure and services to underserved areas of Jefferson County

### **Executive Summary**

Broadband is often cited as the infrastructure of the future. Attracting new businesses, education access, residential appeal and quality of life will be impacted by the availability of a community's broadband service. Jefferson County has parts of the County that are underserved in broadband capabilities. This has been identified as a priority in numerous ways, but most recently through the County's strategic plan. To date, the County has been designated as a Broadband Forward Community by the Wisconsin Public Service Commission and created a Broadband Working Group. Further, the County has set aside funds in the 2019 budget to provide matching dollars towards the development of broadband infrastructure, including technical assistance.

Netwurx Internet, LLC has expressed an interest to continue to develop broadband infrastructure in Jefferson County and has requested to partner with the County to assist with broadband infrastructure development. Netwurx Internet currently has a presence in our County to include sponsorship of the Fair Park, as well as assisting the Town of Watertown in its grant process with the Public Service Commission. In coordination with the Broadband Working Group, Netwurx Internet has developed a plan for phase 1 of its project which will provide broadband service to residential, agri-business and other businesses in Jefferson County this year. This resolution authorizes Netwurx Internet to start phase 1 of this project which will be a test project with the goal of providing broadband service to approximately 257 residential properties, 13 agri-business, 68 other businesses, 2 multi dwelling units and 2 county facilities. The County's portion of the project is anticipated to be \$45,610 with Netwurx Internet contributing \$30,408. The Broadband Working Group considered this resolution at its meeting on April 11, 2019, and recommended forwarding to the County Board for approval.

The Broadband Working Group will continue to develop a phased plan to provide additional coverage across the county, specifically geared towards a 2019 summer grant cycle. These efforts will include working to develop additional partnerships to include working with Dodge County and UW-Whitewater.

WHEREAS, the Executive Summary is incorporated into this resolution, and

WHEREAS, the County's Strategic Plan has identified broadband as being a key infrastructure for Jefferson County, necessary for the County to be competitive, and

WHEREAS, the County recognizes working with partners is needed to provide this service to underserved areas of the County that may not otherwise receive reliable service, and

WHEREAS, initiating this project will make the County more competitive for future grant opportunities, and

WHEREAS, the Broadband Working Group supports the partnership with Netwurx Internet, LLC and Phase 1 of this project.

NOW, THEREFORE, BE IT RESOLVED that the County Board authorizes the County Administrator to enter into a partnership agreement with Netwurx Internet, LLC for phase 1 of the project to develop broadband infrastructure in Jefferson County.

BE IT FURTHER RESOLVED that Jefferson County will continue to seek partners to continue the development of broadband infrastructure in Jefferson County.

Fiscal Note: Costs associated with this partnership will be \$45,610. Funds have been included in the 2019 budget as a contingency line item to implement the strategic plan, account number 11002.599908. These funds will be transferred into the County Administration budget account number 11101.533228 (Administration – Internet). This is a budget adjustment. County Board approval requires a two-thirds vote of the entire membership of the County Board (20 votes of the 30 member County Board).

# Accepting bid for one enclosed custom tandem axle trailer for the Jefferson County Sheriff's Office Dive Team

# **Executive Summary**

The Jefferson County Sheriff's Office solicited bids from vendors for the purchase and delivery of one enclosed custom tandem axle trailer with a 12,000 pound gross vehicle weight rating for the purpose of transporting equipment used by the Jefferson County Sheriff's Office Dive Team. The County Administrator reviewed the bid and recommended forwarding this resolution to the County Board to accept the bid from LVD Custom Specialty Vehicles as the only bidder at a cost not to exceed \$77,454.

WHEREAS, the Executive Summary is incorporated into this resolution, and

WHEREAS, the Jefferson County Sheriff's Office received bids to purchase one enclosed custom tandem axle trailer for the Jefferson County Sheriff's Office Dive Team, and

WHEREAS, bids were received with the following results:

# Applying for a Wisconsin Department of Natural Resources Flood Mitigation grant.

### **Executive Summary**

The Jefferson County Emergency Management Department is requesting County Board authorization to apply for a Wisconsin Department of Natural Resources grant to be used for the acquisition and demolition of flood damaged properties in Jefferson County. If awarded, this DNR grant will be combined with other state and federal grant funds from the Hazard Mitigation Grant Program and used to purchase three properties in Fort Atkinson, two on Rock River Road and one on State Highway 106. Participation in this program by owners of flood damaged properties is voluntary.

WHEREAS, the Executive Summary is incorporated into this resolution, and

WHEREAS, the Jefferson County Emergency Management department participates in the flood mitigation program for the purpose of purchasing and demolishing flood damaged properties, and

WHEREAS, the cost of such acquisitions are funded using state and federal grant funds, and

WHEREAS, this grant application must be accompanied by a resolution from the Jefferson County Board of Supervisors supporting acquisition of these flood damaged properties.

NOW, THEREFORE, BE IT RESOLVED that the Emergency Management Department is hereby authorized to apply for a Wisconsin Department of Natural Resources grant in the amount of up to \$10,000 to be applied toward the acquisition and demolition of flood damaged properties in Jefferson County.

Fiscal Note: The total cost of property acquisition and demolition is \$10,000. Funding for flood mitigation properties may be combined with other grant funds. If any grant funds remain following these acquisitions, they may be used to purchase additional flood mitigation properties in the future. There will be no tax levy dollars used for these acquisitions. If received, the Finance Director is authorized to make the necessary budget adjustments. This is a budget adjustment. County Board approval requires a two-thirds vote of the entire membership of the County Board (20 votes of the 30 member County Board).

# Entering into a Memorandum of Understanding with the City of Oconomowoc and the Oconomowoc Library Board.

# **Executive Summary**

Jefferson County, working with the Jefferson County Library Board, administers a non-countywide tax levy to support libraries based on use by residents. Jefferson County provides funds to libraries within the County and is required by law to reimburse adjacent counties for use of their libraries by Jefferson County residents at a minimum of 70% of their circulation costs. The Oconomowoc library receives the majority of these funds due to its proximity to Jefferson County and being the closest library for residents in northeast Jefferson County, including the Oconomowoc area. Due to the growth of this area, the use of the Oconomowoc library by Jefferson County residents continues to increase.

Under state law, Counties have the authority to appoint members to local library boards to represent their interests, with county membership based on the proportion of county funding. However, this statute only applies to library boards with libraries located in the County. As a result, Jefferson County does not have the statutory authority to appoint members to the Oconomowoc library board. The County Administrator and the Bridges Library System Director met with representatives of the City of Oconomowoc and its library board to discuss representation of Jefferson County on the Oconomowoc library board based on the funding provided by the County and the library's use by Jefferson County residents. This Memorandum of Understanding authorizes the Jefferson County Administrator to appoint an ex-officio member to the Oconomowoc Library Board to represent the interests of Jefferson County. The Executive Committee considered this resolution at its meeting on March 27, 2019 and recommended forwarding to the County Board for approval.

WHEREAS, the Executive Summary is incorporated into this resolution, and

WHEREAS, Jefferson County's Strategic plan has identified intergovernmental cooperation as a goal of the County, and

WHEREAS, the County provides funding to the Oconomowoc Library based on utilization of the library by Jefferson County residents, and

WHEREAS, it is desired that Jefferson County have representation on the Oconomowoc Library Board in consideration for the funding provided by Jefferson County.

NOW, THEREFORE, BE IT RESOLVED that the County Board authorizes the County Administrator to enter into a Memorandum of Understanding with the City of Oconomowoc and the Oconomowoc Library Board to appoint an ex-officio member to the Oconomowoc Library Board to represent the interests of Jefferson County.

Fiscal Note: Standard mileage and per diem rates would apply to this appointment and be charged to the Library Administration budget.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF OCONOMOWOC, THE OCONOMOWOC PUBLIC LIBRARY BOARD OF TRUSTEES, AND JEFFERSON COUNTY

#### RECITALS

- A. The Mayor of the City of Oconomowoc, with the approval of the Common Council, appoints members to the library board. Wisconsin State Statute 43 prescribes the makeup of the library board. The statute requires representation of non-City residents of the home county who live in municipalities without libraries ("True Non-Resident," or TNR) when home county TNR circulation (and thus, funding from the home county) reaches prescribed levels. The library board currently consists of two home county TNR residents, one representative of the school superintendent, one representative from the Common Council, and five City residents.
- B. The statute does not require library board representation of adjacent counties, regardless of those adjacent counties' TNR library use.
- C. The statute requires adjacent counties to annually reimburse municipalities a minimum of 70% of the operating cost of serving that county's TNR citizens.
- D. Jefferson County reimburses the City of Oconomowoc at the statutory minimum, and does not have a representative on the library board prior to the City, the library board, and Jefferson County entering into this MOU. Due to the amount of Jefferson County TNR residents' use of the Oconomowoc Public Library, Jefferson County's reimbursement comprises a significant portion of the library's annual budget. However, due to Jefferson County currently reimbursing at the statutory minimum, this amount does not fully reimburse the cost of serving Jefferson County TNR residents.
- E. This MOU, while not a legally binding document, indicates a voluntary agreement for the addition of one non-voting ex-officio member, appointed by the Jefferson County Administrator with Jefferson County Board confirmation, and the approval of the Mayor and Common Council of the City of Oconomowoc. The non-voting ex-officio member shall represent Jefferson County to the City and the library board, and the City and the library board to Jefferson County.
- F. Jefferson County, the City and the library board agree to proactively review the library's operational costs and needs, specifically due to the impact of Jefferson County residents' use of the facility and the correlation to the current reimbursement rate by the County to the library.

### UNDERSTANDING OF THE PARTIES

As noted in the Recitals, this MOU is not a binding agreement. Rather, it sets forth certain agreements among the parties involved:

1. One non-voting ex-officio member will be appointed by the Jefferson County Administrator with Jefferson County Board confirmation, and the approval of the Mayor and Common Council of the City of Oconomowoc. The non-voting ex-officio member shall represent Jefferson County to the City and the library board, and the City and the library board to Jefferson County. The non-voting ex-officio member will not be eligible to serve as an officer, and his or her attendance will not affect quorum. The non-voting ex-officio member is eligible to serve on committees of the library board, but is not permitted a vote on matters before any committee.

- 2. The term of this non-voting ex-officio member will be three years.
- 3. Upon the completion of the Jefferson County member's first year, the parties will reconvene to determine the advisability of continuing this arrangement.
- 4. Should the arrangement become untenable for any of the parties, the arrangement can be terminated with written notice.

# Amending the 2019 Jefferson County Parks Department Budget

# **Executive Summary**

As part of Segment 1 of the construction of a multi-use recreational trail from Watertown to Oconomowoc known as the Interurban recreation trail, a bridge was constructed and installed over the Rock River by River Road in Watertown. During the installation of the bridge, the trail from River Road to the bridge sustained damage from the equipment used to install the bridge. As a result, the trail is in need of repair and We Energies, owner of the trail right-of-way, requested that such repair include paving the connection between River Road and the recently installed bridge, which is consistent with the trail plan.

Because the installation of the bridge was more costly than anticipated, the funds originally budgeted for the paving project were used for the installation of the bridge. Reserve funds committed for Parks projects by the Carol Liddle estate have been included in the 2019 budget in the amount of \$84,230.45, but were not designated for any particular project. Using these funds as proposed requires a budget amendment. This resolution amends the Parks Department budget to authorize the Parks Department to utilize these funds to pave the trail connection from River Road to the bridge. The Finance Committee considered this resolution at its meeting on April 11, 2019 and recommended forwarding to the County Board for approval.

WHEREAS, the Jefferson County Board of Supervisors has approved the construction of a multi-use recreational trail from Watertown to Oconomowoc known as the Interurban recreation trail, and

WHEREAS, segment one of the project is substantially complete, pending the paving of the connection between the completed bridge over the Rock River and River Road in the town of Watertown, and

WHEREAS, the Parks Department desires to complete and open segment one of the project for public use, and

# Creating a full-time Building Maintenance Worker I position in the Central Services Department

### **Executive Summary**

Currently, the Central Services staff is responsible for maintaining and providing oversight of capital projects to the Jefferson County Courthouse, MIS facility, County Jail and Sheriff Buildings, including the Sheriff's main office, range and annex buildings. In addition to administrative, long-term strategic planning and capital project planning functions, the specific daily needs include building maintenance and custodial services, fundamental repairs, carpentry and electrical services to buildings, snow removal, assuring other pedestrian walk-way safety issues, conference room set-up and take-down, interdepartmental mail services, and being on call 24/7 for emergencies at the Jail. At present the Central Services staff consists of one Director of Maintenance, one Building and Maintenance Foreman, one Building Maintenance Worker II, one Central Service Worker, and three Custodians (2 full-time and 1 funded part-time). The Director of Maintenance position has been vacant since May, 2017, and the daily administrative, supervisory and project management tasks were delegated to a Maintenance Worker, who was reclassified to the Foreman position. After assuming these duties, the Foreman now spends less than half of his time on the daily general maintenance of the facilities. In addition, there is only two staff available to be on-call 365 days of the year.

With the Director position vacant, the creation of a full-time Building Maintenance Worker I position will provide the staffing needed to perform routine and preventative maintenance to buildings and grounds to assure the safety of citizens, visitors and employees. The new Building Maintenance Worker I position will also be included in the 24/7 on-call rotation and be able to provide flexibility in custodial coverage in the evenings. Attempts have been made to recruit limited-term staff and contracted staff to assist with ongoing, unfinished and on-hold projects. However, the inability to retain and lack of consistency have made these efforts unsuccessful.

On March 25, 2019, the Human Resources Committee reviewed the request from the County Administrator and recommended forwarding this resolution to the County Board to create one full-time Building Maintenance Worker I position in the Central Services Department.

WHEREAS, the above Executive Summary is incorporated into this resolution, and

WHEREAS, routine and preventative maintenance, as well as short and long-term projects of the Jefferson County Courthouse, MIS facility, and the County Jail and Sheriff's facilities are not adequately being performed with current staffing levels, and

WHEREAS, the creation of a full-time Building Maintenance Worker I position will provide the additional staffing needed to perform the maintenance and projects currently unable to be completed, and

WHEREAS, attempts to hire limited-term staff or contracted staff has been unsuccessful.

NOW, THEREFORE, BE IT RESOLVED that the 2019 County Budget setting forth position allocations in the Central Services Department be and is hereby amended to create one full-time Building Maintenance Worker I position in the Central Services Department, to become effective upon passage.

Fiscal Note: This resolution amends the budget by funding the Building Maintenance Worker I position and defunding the Director of Maintenance position. This is a budget adjustment. County Board approval requires a two-thirds vote of the entire membership of the County Board (20 votes of the 30 member County Board).

### **Executive Summary**

The Jefferson County Parks Department is in the process of constructing a recreation trail for hiking, biking and cross-country skiing on right-of-way owned by We Energies. The proposed trail is 10.96 miles in length and is located between the City of Watertown, Wisconsin, and the City of Oconomowoc, Wisconsin. This off-road paved trail connection will be built on the former Interurban Rail Line that connects the City of Watertown to the City of Oconomowoc. The path cross-section will consist of a 10-foot wide asphalt surface with 2-foot wide aggregate shoulders. An 8-inch stone base with 3-inch asphalt layer will be used. The project is located primarily in Jefferson County (10 miles) and a portion in Waukesha County (1 mile). The old interurban rail line, which at one time connected the City of Watertown with the City of Milwaukee, is now a utility corridor owned by We Energies which has granted a license to use this property as a recreation trail. This resolution authorizes the County Administrator to apply for, and if awarded, to accept these grant funds for the purpose of construction of the second segment of this recreational trail. # Proclaiming the month of April 2019 as Alcohol Awareness Month

WHEREAS, Alcohol Awareness Month was established in 1987 to help reduce the stigma so often associated with alcohol addiction by encouraging communities to reach out to the American public each April with information about alcohol, alcohol addiction, and recovery, and

WHEREAS, Alcohol Awareness Month provides an opportunity to decrease stigma and misunderstandings in order to dismantle the barriers to treatment and recovery, and thus make seeking help more readily available to those who suffer from this disease, and

WHEREAS, alcohol addiction is a chronic, progressive disease, genetically predisposed and fatal if untreated, and

WHEREAS, it is estimated that as many as 20 million individuals and family members are living lives in recovery from alcohol use in the United States, and

WHEREAS, many people begin consuming alcohol when they are under the legal drinking age, and

WHEREAS, underage alcohol consumption costs Wisconsin nearly \$1 billion annually in medical care, missed work, traffic crashes and pain and suffering, and

WHEREAS, the healthy growth and development of Wisconsin's children requires further reduction in underage drinking, and

WHEREAS, in Wisconsin it is illegal for adults to allow or fail to take steps to prevent underage drinking on property they own or under their control, or to provide alcohol to those under the legal drinking age, and

WHEREAS, enforcement of laws against providing alcohol to underage people combined with parental support and communication can reduce underage drinking, and

WHEREAS, the Jefferson County Drug Free Coalition will work with youth, schools, parents and other community partners to support activities that increase awareness of underage drinking among middle and high school students, and

WHEREAS, the Jefferson County Sheriff's Office will work with local police departments to rigorously enforce laws against selling or serving alcohol to underage people, and

WHEREAS, the Jefferson County Board of Supervisors strongly encourages responsible adults to refuse to provide, alcoholic beverages to underage people and to take the necessary steps to hold those who engage in this illegal and unhealthy practice responsible.

NOW, THEREFORE, be it resolved that the Jefferson County Board of Supervisors not only discourages the use of alcohol by those below the legal age of consumption, but also encourages all residents to refuse to provide alcoholic beverages to those under the legal age for consuming alcohol, and pledges to support all law enforcement efforts to identify and deter this illegal and unhealthy activity.

BE IT FURTHER RESOLVED that the Jefferson County Board of Supervisors hereby proclaims the month of April 2019 to be Alcohol Awareness month with an emphasis on preventing the consumption of alcohol by those under the legal drinking age.
