Mr. Walter read Resolution No. 61.

WHEREAS, a request has been made for authorization to lay out and use a trail for snowmobiling across several fields at Countryside Home and Hospital,

WHEREAS, the proposed trail on County-owned land is a necessary segment of a long trail from the City of Jefferson to the Crawfish River and to other distant points,

WHEREAS, a number of counties have accommodated the recreational use of snowmobiles by laying out trails on county-owned land,

WHEREAS, the Agricultural and Conservation Committee has recommended approval of the proposed snowmobile trail,

RESOLVED: that a snowmobile trail is hereby authorized through the northerly field (between Wisconsin Drive and C.T.H. "J") to the gates at the southwesterly corner of said field; across C.T.H. "J" and northwesterly across the present County cornfield to the Crawfish River.

BE IT FURTHER RESOLVED that travel on the aforementioned trail shall be by direct route as indicated by trail markings and nothing contained in this resolution shall authorize random snowmobiling upon County-owned fields

BE IT FURTHER RESOLVED that permission is hereby granted to erect one gate through the existing fence adjacent to Wisconsin Drive.

BE IT FURTHER RESOLVED that the Administration and Trustees of Countryside Home and Hospital shall be authorized to supervise the laying out of the aforementioned snowmobile trail and to report any complaints to the County Administrator, it being understood that the aforementioned snowmobile trail shall be used on a trail basis and that any substantial complaints arising out of the use of said trail will result in a termination of the use of said trail.

Mr. Walter moved that Resolution No. 61 be adopted. Seconded and unanimously carried.
