Completeness Determination on Application for Expanded Livestock Facility

The Land and Water Conservation Department (LWCD) has reviewed the application, worksheets, and supplemental information submitted on December 18, 2017, and January 2, 22, 24, 25, and 29, 2018 by Daybreak Foods Inc. for a proposed livestock expansion of their facility located on Crossman Road in the Town of Lake Mills. After reviewing the application, maps, worksheets, construction specifications, and supplemental information the Land and Water Conservation Department has determined that all of the requirements have been fulfilled. We recommend that the Zoning and Planning Committee find the application from Daybreak Foods Inc. to be complete.

Summary of Expansion Plans

Daybreak Farm Inc. plans to increase their livestock numbers from 1,800,000 chickens to 2,750,000 chickens or 27,500 animal units. This expansion will include:

- 5 new cage free chicken layer barns (and the removal of 9 existing layer barns)
- 3 new chicken pullet barns and 1 existing pullet barn (and the removal of 2 existing pullet barns)
- 1 new manure storage facility and associated manure transfer systems from the 5 new layer barns
- 1 new manure storage facility for the pullet manure
- 2 existing manure compost buildings that will only be used for manure if there is an emergency situation (1 existing compost building will be closed)

Requested Permit Requirement

The LWCD urges the Zoning and Planning Committee to require the following statements be added to the new permit if granted:

 Annual nutrient management plan updates shall be submitted to the Land and Water Conservation Department by September 30th of each year for the following crop year. These updates shall account for any nutrients applied to farmland.

- The LWCD must be informed of the pre-construction conference and when work will begin on the manure storage structures.
- Per Jefferson County Zoning Ordnance [11.05 (d) 2. d], the manure storage structure certification "shall be filed at least 10 days prior to population of the facilities by the animal unit count approved under the permit." As-builts should be sent to the Land & Water Conservation Department upon certification.
- Per the Livestock Siting Law [ATCP 51.08 (2)] within 2 years the livestock operator must begin populating the approved facility and begin construction on every new or expanded livestock housing structure, as well as every new or expanded waste storage structure, proposed in the application.
- Any alterations or additions to the operation after the permit is issued that changes one
 of the worksheets or application requires a permit update or new Livestock Siting
 Application depending on the circumstance.

RESOLUTION NO. 2017-___

Amending Land Information Plan to Include Unmanned Aircraft Systems Program

Executive Summary

An Unmanned Aircraft Systems (UAS) workgroup with representatives from Administration, Corporation Counsel, Highway, Land and Water Conservation, Land Information, Parks and the Sheriff's Office was formed in 2017 to study the use of UAS in county government. workgroup identified numerous potential benefits of a UAS program for public safety, transportation, recreation and conservation. A budget of \$17,000 was recommended in the 2018 Land Information Program Budget for UAS training, equipment and software. The UAS workgroup will continue to develop appropiate training, policies and standard operationg proceedures to implement a safe, ethical and sustainable UAS prgram. Wisconsin Statutes requires expenditures from Land Information Program funds to implement the goals and objectives of the County Land Information Plan. The Jeffeson County Land Information Plan, developled in December of 2015 and adopted in March of 2016, does not include a UAS program. To maintain compliance with Land Information Program requirements, the Land Information Plan should be amended to include a UAS program. The Land Information Council recommended approval of the UAS program budget and amending the Land Information Plan on July 27, 2017. The Planning and Zoning Committee met on February 26, 2018, and recommended forwarding this resolution to the County Board for approval.

WHEREAS, the Executive Summary is incorporated into this resolution, and

WHEREAS, Unmanned Aircraft System collection and analysis of land information would benefit numerous county governmental operations, and

WHEREAS, funding for an Unmanned Aircraft System program was approved in the 2018 Land Information Program Budget, and

WHEREAS, Wisconsin Statute 59.72 (5) (b) 3. requires that Land Information Program funds are to be used to develop, implement and maintain the countywide plan for land records modernization.

NOW, THEREFORE, BE IT RESOLVED that the County Land Information Plan goals and objectives be amended to include development of an Unmanned Aircraft Systems Program.

Fiscal Note: The non-tax levy Land Information Program funded by a portion of the document recording fees in the Register of Deed's Office accounts 12503.521220, 12503.521296 and 12503.594810 will fund the UAS expenditures at a cost not to exceed \$17,000.
