

- 1. With the approval of the Sheriff, Deputy Steve Ganser has joined the Jefferson County Treatment Court Team. This fulfills one of the Treatment Court Standard recommendations of having a law enforcement member as part of the team. His perspective is already influencing the Team's decision making process in a very positive way and his contributions to Team deliberations are very much appreciated.
- 2. Judge Brantmeier and Judge Dehring attended the Judicial Education Seminar on Treatment Courts earlier this month. Both stated the seminar was very informative.
- 3. Jefferson County is awaiting word on whether or not our application for expanding treatment programming through a SAMHSA grant was approved. If selected, Jefferson County would be able to expand treatment offerings to include an Intensive Outpatient Group. Funding would also allow for the creation of a Peer Support/Mentoring program staffed with a halftime coordinator position along with transportation assistance for Treatment Court participants. No timeframe was given for an approval decision.
- 4. If the SAMHSA grant is not approved, efforts to seek funding through a Federal Bureau of Justice Assistance may be sought. There have been four webinars to prepare for this grant over the last month and another is scheduled for next week.
- 5. Three Alcohol and Drug Treatment Court graduates agreed to apply for Certified Peer Support Specialist training. Applications for the class are still pending following interviews which occurred last week.
- 6. The Treatment Courts will be hosting the next graduation Celebration on March 13, 2019. Justice Dallett can no longer speak at the ceremony. A new speaker is being sought. There will potentially be several recent graduates in attendance. There are potentially 14 graduates who could be in attendance at this celebration.
- 7. The Jefferson County Drug Free Coalition has sponsored 2 Narcan training session over the past month with two more scheduled for 3/6/19 at the Lake Mills Library and 3/20/19 at the Watertown Library. Spanish translations services will be available at the 3/20/19 training session.
- 8. Jefferson County will be issuing Procedural Fairness Surveys beginning in March, 2019. These surveys are required for the Treatment Alternatives and Diversion (TAD) program funding and will help measure program effectiveness and fairness from participants' perspectives. These surveys will be entered into CORE by the Department of Justice and will have limited impact on staff time.




**BEEN INCARCERATED WITHIN LAST 3 YEARS** 



**REASON FOR INCARCERATION** 




**DRUGS OR ALCOHOL RELATED** 




**TYPE OF SUBSTANCE USED** 










**WEAPONS USED** 




