

1. The Treatment Court Team continues to develop a Peer Support Mentoring Group. Jefferson County is seeking trainers to train and certify graduates as Peer Support Specialists. Groups will occur monthly and a venue for holding the groups is being sought. Curriculum also has to be developed. This project is ongoing, with a possible start date in the Fall.
2. The Treatment Court Team will begin surveying participants to identify non-candy related small tangible incentives. Many participants decline to take these incentives and alternatives will be sought.
3. The SAMHSA grant application was not approved for expansion of treatment services. New funding opportunities for establishing an IOP group will be sought.
4. The Treatment Court Programs held a graduation celebration on July 17<sup>th</sup>, 2019. Kelli Thompson was the featured speaker in which 4 of 9 recent graduates were able to attend with their families.
5. The Department of Justice and the WI Association of Treatment Court Professionals is hosting Treatment Court Standards training for new Team Members in the coming weeks. It is anticipated that the newer Team members will attend the one day training in Janesville in August.
6. Recommended language to include DOC ATR's into the Drug Treatment Court is still being developed and should be available at the next meeting.
7. There is no update on DOJ CORE reports.
