General Info

- The Jefferson office is now under shared management with Rock County
 - Dave Gundlach will be leaving District Conservation position on November 5th
 - A temporary Acting DC will start on November 7th
 - An announcement requesting applicants for a 120 day detail starting December 5th has been sent out
 - October 29th is the deadline for applications to be submitted
- The vacancy announcement for a Resource Conservationist in the Jefferson office opened (again) on 9/13 and closed on 9/21/2021
 - \circ The panel of qualified applicants has been delayed with no ETA at this time
 - Interviews and a selection will need to be completed within 2 weeks following receipt of the panel from the staffing office

CRP

- 18 re-enroll and new contracts started on 10/1/2021
- 1 new plan revision for the Forest Management Incentives program

EQIP practices in progress


- Abendroth lined waterway project is seeking bids and should be constructed once crops are off
- Ebbott has a system of terraces and waterways planned for construction
- Koellen will be installing a well and pipeline system for grazing watering facilities
- Back Road Beef waste storage facility has been installed. As-built construction documents are under review
- Stilling grassed waterway is completed and the EQIP contract is completed

2022 EQIP signup

- FY22 application deadline cutoff is November 19
 - There are 15 unfunded applications from 2021 that will be deferred to 2022
- For General EQIP funding in the cropland, pasture, and forest/wildlife fund pools, Jefferson County has been combined with Columbia, Dane, and Rock Counties in the Driftless End Moraines local work group
- For 2022, Conservation Activity Plans have been changed to CPA, DIA, and CEMA: Conservation Planning Activities, Design and Implementation Activities, and Conservation Evaluation and Monitoring Activities

Conservation Stewardship Program (CStwP)

- 2017 CStwP contracts are set to expire 12/31/2021
 - o 8 participants have filed renewal applications for 2022
 - Renewal contracts need to be obligated by 12/30/2021
- Annual CStwP payments will start October 11, 2021
 - There are 18 contracts in good standing
 - All are in process of being paid

Distribution will be mid-spring. Information will be sent out to notify customers of pickup location, dates, and times. Trees are perishable and need to be picked up promptly to help ensure their viability. **We cannot hold orders, nor do we deliver.** If you can't make it to pickup, please make arrangements for someone else to pick up your order at the designated times. Trees not collected on the pickup date will be donated and refunds will not be given.

Coniferous Trees

2-2 Arborvitae - Height of 20-30 ft., width 8-10 ft. Year-round color. Forms a wind tight barrier when used for screening or as hedging. Prefers heavy damp areas. Adapts well to other soil types.
12-16" \$30 (Per Bundle of 25)

2-3 Fraser Fir - Often referred to as the Cadillac of Christmas trees. Has an excellent fragrance and exceptional needle retention. Likes cool, moist, well drained soil. Full to partial sun. Will not do well in heavy, wet clay soil. **12-16**" **\$30 (Per Bundle of 25)**

2-2 White Pine - Grows over 35 ft. Vigorous growing, open tree with long, soft, bluish-green needles.
Used in ornamental plantings. Tolerates shade and grows well in a variety of soils.
7-15" \$30 (Per Bundle of 25)

2-3 Black Hills Spruce - Short, stiff, dark green needles and a spicy scent. Extremely hardy, withstanding heat and dry growing conditions. Used as an ornamental, windbreak, or as a Christmas tree. **7-15**" **\$30 (Per Bundle of 25)**

2-2 White Spruce - Short, sharp, pale green needles and upright, dense branches. A popular Christmas tree as well as an ornamental and windbreak tree. Endures drought conditions well.

Deciduous Trees and Shrubs

American Plum - 1 Yr. Seedling - Grows 15-20 ft. A small tree or large shrub. White flowers in early May. Edible fruits - red or yellow. Very hardy and drought resistant. Excellent for wildlife plantings. 12-18" \$25 (Per Bundle of 10)

Hazelnut - 2 Yr. Seedling - Small shrub often in clumps. Edible brown nuts. Grows best in moist, well-drained soils but will adapt to most types of soils. Full sun or partial shade. Attracts wildlife such as deer, grouse, turkeys, pheasants, and quail. **12-18**" **\$25 (Per Bundle of 10)**

Sugar Maple - 1 Yr. Seedling - Outstanding native shade tree. Dark green leaves turn yellow to orange to fiery red in fall. Grows in most soil types. Sap used for maple syrup. Used as an ornamental, for lumber, and wildlife habitat. **12-18**" **\$25 (Per Bundle of 10)**

Swamp White Oak - 2 Yr. Seedling - Does well in moist to wet soil, also in upland areas. Shiny dark green leaves. Yellow to purple fall color. Their sweet acorns are great for wildlife. 12 - 18" \$25 (Per Bundle of 10)
