

Organizational Chart and Structure


- Blend of local government and responsibilities as "arm of the state"




Budget and Financial Information

- \$109.6 million budget
 - Total Tax Levy: \$32.7 million (29.8%)
- 2025 Mill Rate: 2.8049
- Nine of past ten years had Mill Rate decrease
- Two consecutive years of reduction in Levy and Mill Rate
- Maintain Aa2 Bond Rating
- Priority-Based Budgeting





Housing Studies

- Housing Summit on May 18, 2023
- "Residential Market Analysis" study by Tracy Cross & Associates published May 20, 2025
- Thorough investigation of Jefferson County and surrounding areas to identify factors expected to impact residential potentials going forward
- Detailed analysis of all relevant employment, demographic, and residential trends/statistics
- Thorough assessment of both the rental apartment and for sale/ownership sectors of the Jefferson County housing market
- Demand forecast for residential development in Jefferson County over the next 5+ years

Residential Market Analysis

- "First and foremost, current conditions in the residential marketplace lend full support for the demand/need for new residential development..."
- "As it relates to the ownership sector of the market, supply-side constraints are also apparent, especially for moderately priced mainstream product."
- "...growth in the county remains positive, which, too, bodes well for future housing initiatives."



Residential Market Analysis (cont'd)

- "Fostered by a stable economy, and on the heels of expected positive household growth, construction requirements for new housing in Jefferson County will average a minimum of 385 units annually..."
- "This market reality represents an opportunity for housing initiatives across the county."
- "[Beyond derived demand], the overall base of residential construction requirements could actually be higher during any given year where properly positioned supply is made available."



Planning for New Housing

- Full market study available on ThriveED website
- Economic and demographic forecasts call for a mixture of housing types and housing price points
- Strategic Plans from ThriveED and Jefferson County echo these forecasts, with intentionality
- Commercial and personal housing assistance, such as Live Local Development Fund and HUD Counseling
- Increased advocacy, education, partnerships







- Gate Receipts up 32%













County Highway System
