Pam Rogers called the meeting to order at 8:31 a.m. with all committee members present. Staff members present were Dave Ehlinger, Gary Petre, Phil Ristow and Tammy Worzalla. Additional County Board members present were Ron Buchanan, Jan Roou, and Carlton Zentner.

Gary Petre certified that the meeting was in compliance of the Open Meetings Law for the State of Wisconsin.

Under citizen comments, Jan Roou indicated that she felt it might be appropriate for Jim Braughler to abstain from voting on the library budget due to his working with the Lake Mills library. After general discussion, Phil Ristow opined that there probably was no conflict of interest, but that Jim could abstain to be safe. Roland Welsch presented the project by the City of Jefferson moving the County's fiber optic cables. Dave Ehlinger indicated that the contingency fund currently has a balance of \$282,564.66 and recommended that the funding for the project come from the contingency fund. A motion was made by Jones/Molinaro to transfer \$30,155.74 from the contingency fund to the MIS Department for the fiber optic cable movement project. The motion passed 5-0.

A motion was made by Rogers/Mode to convene in closed session pursuant to Wisconsin Statute §19.85(1)(e) for the purpose of deliberation or negotiating the purchase of property at 215 S Center Street in Jefferson. By a roll call vote, the motion passed 5-0.

After general discussion, a motion was made by Mode/Jones to reconvene in open session. The motion passed 5-0.

The committee discussed the property and took no further action.
