## 11. Discussion and possible action on phone plans and reimbursement

Supervisor Molinaro talked with the County Treasurer, County Administrator, and several department heads on this subject. They felt that too much unproductive staff time is being spent reviewing telephone bills for identifying the cost of personal calls.. The Computer, Internet and Telephone Policy addresses this issue. It was suggested that the Department Heads review the bills for potential abuse and end the process of each individual spending time going over the phone bill to calculate the cost of personal calls. The committee will forward this recommendation to the Human Resources Committee for their input.

#### 12. Update on alternative energy source project

Supervisor David told the committee several meetings have taken place to discuss potential areas of energy saving improvements. Currently they are looking at the efficiency of lighting and motors and other ways to reduce energy usage. They are also working with WE Energies on a 5 year energy plan. Supervisor David will keep the committee up-to-date as more information becomes available. The

committee recommended that Supervisor David, Mark Miller, and Terry Gard attend an upcoming training on alternative energy sources.
