1. CALL TO ORDER

6. DISCUSS URT PROCESSING'S PROPOSAL FOR E-WASTE MANANGEMENT IN JEFFERSON COUNTY

URT sent a copy of the contract that was proposed for Jefferson County and Sharon had forwarded a copy to the Committee, Corporation Counsel, Watertown, Fort Atkinson, and Ixonia. Jeff DeGarmo introduced himself to everyone in attendance. Jeff also explained that URT (Universal Recycling Technologies) was the new name for CRT (Cathode Ray Tube). They changed the name to better represent all the materials that they recycle. Jeff asked if anyone had any questions about the contract submitted by URT. Sharon asked that a statement be put in the contract to explain the URT name charge. It was agreed that 75,000 pounds of electronics would be a good target for the time period between January 1 and June 30, 2010. Tom K. is going to look into a trailer or pod that can be put in place at the compost center; Jeff D. is also looking into what is available. Vic K. and Rick S. both said that their sites could start operation by the end of January. Sharon will post operation times and sites on the Jefferson County website and send out a news release at the end of January. It was agreed that we would ask residents not to bring electronics at the clean sweeps but instead take them to the recycling sites. Rick S. & Tom K. both said that if someone did bring something they could take it to the recycling site. We could also send the resident to the recycling site that day. Sharon will make a draft showing sites, locations, address, and operation hours and have the draft approved before posting to the county website and sending out to residents.

Vic Imrie made a motion after discussion to approve the URT Processing contract with the two noted changes (name change notation and addition of collection sites). The program will start January 1, 2010 though June 30, 2010. A purchase order will be needed for any additional cost above the agreed contract amount. Carlton Zentner seconded the motion.
