- 3. Certification of compliance with the Open Meetings Law. Verification of notice of meeting by G. Petre.
- 4. Review of Agenda. No changes made.
- 5. <u>Citizen Comments.</u> Jim Garity and Dale Naatz each spoke regarding being in favor of keeping pay practices the same at the Highway department, particularly in regards to overtime
- 6. <u>Approval of minutes.</u> Motion by L. Zastrow, second by D. Schultz, to approve the September 20, 2011 minutes, as presented. Motion carried 5:0.
- 7. Motion by M. Delany, second by L. Zastrow, to support a request to Finance Committee for a transfer of funds from contingency for labor negotiation consulting fees of William Bracken from Davis and Kuehlthau, S.C., not to exceed \$25,000. Motion carried 5:0.
- 8. Motion by C. Peterson, second by M. Delany, to recommend a resolution to eliminate a full-time Lead Intake Worker position and create a full-time Intake Worker position at Human Services. Motion carried 5:0.
- 9. Motion by D. Schultz second by L. Zastrow, to recommend a resolution to eliminate one part-time File Clerk position and one part-time vacant Medical Records Secretary position and to create one full-time Medical Records/File Clerk position at Human Services. Motion carried, 5:0.
- 10. Review of Resolution 2004-50, insurance coverage for active military employees and their families, completed. No action taken to amend.
- 11. Review of Resolution 2004-51, vacation accrual for employees on active military duty. No action taken to amend.
