The Jefferson County Highway Committee and Infrastructure Committee met on Wednesday, January 19, 2011, at 8:30 A.M. for a joint meeting at the Jefferson County Highway Department.

Purpose of the meeting was to discuss and take possible action on proceeding with the process of determining future Highway Department facility needs.

### **PUBLIC COMMENT**

Carl Zentner stated that the Committees should consider the "letting out of work" instead of building a new facility. He feels that there would be considerable cost savings. He stated his feelings on reducing the work force at the Highway Department and the possibility of staying competitive as far as pricing is concerned.

# <u>6. Discussion and possible action on selection of a consultant for the Facility Site Selection Analysis Project.</u>

Highway Commissioner Kern stated that a total of twelve proposals were received for the site selection analysis. The proposals were reviewed and ranked by the County Administrator, Highway Commissioner, and the Highway Operations Manager. The proposals were ranked according to experience in doing a study and design, experience on a large facility design, proposal and understanding of the scope of the project, actual cost, and experience doing highway department designs. The top four composite rankings are as follows: 1) Barrientos Design, Milwaukee 2) Short Elliott Hendrickson, Chippewa Falls 3) Angus Young and Associates, Janesville 4) Kueny Architects, LLC, Pleasant Prairie. Barrientos Design was ranked number one based on their experience with county highway facilities. Barrientos is currently working with the Calumet County Highway Department.

The evaluation of Jefferson County Highway Department includes evaluation of the current site and outlying shops and two additional sites. The pros and cons will be evaluated for each site, such as utilities, roads, and cost estimates of each site. The time frame for this should be two to three months.
