#### 1. Call to Order

The meeting was called to order by Chairman Nass at 8:30 a.m.

# 2. Roll Call

Nass, David, Reese and Rinard were present. Jaeckel was absent. Zoning Department staff in attendance included Rob Klotz, Michelle Staff and Deb Magritz. John Molinaro, County Board Chairperson and Andy Erdman, Land Information Director were also present.

# 3. Certification of Compliance with Open Meetings Law Requirements

Reese verified that the meeting was being held in compliance with open meeting law requirements.

# 4. Review of Agenda

No changes were proposed to the agenda.

# 5. Public Comment (Not to Exceed 15 Minutes and Not to Include Petitions Slated for Decision)

There was no public comment.

# 6. Approval of October 29, November 12 and November 15 Meeting Minutes

Motion by Rinard, seconded by Reese to approve the October 29 minutes as presented; motion carried on a voice vote with no objection. Motion by Reese, seconded by David to approve the November 12 minutes as presented; motion carried on a voice vote with no objection. Motion by David, seconded by Rinard to approve the November 15 minutes as presented; motion carried on a voice vote with no objection.

# 7. GIS Technical Support and Future Program Development

Erdman began by explaining that there was a corrupted GIS file which kept staff from using the program at our last Planning and Zoning Committee decision meeting. He proposed upgrading the software, giving more options for support of the program and allowing incorporation of pictometry. There has been \$40,000 set aside in the 2013 Land Information budget, which could be used to hire an outside consultant to develop a new version of the software. Klotz asked whether \$40,000 would be enough funding for the project, and Erdman responded that he explains the upgrades to cost less than that.

#### 8. Light Detection and Ranging (LiDAR) Project Update-Andy Erdman

Erdman reported that he'd received delivery of the LiDAR data in mid-October. He explained that for Zoning Department purposes, one advantage is that this may help

customers in getting a Letter of Map Amendment. Erdman answered a question by saying that this information has a "life expectancy" of about ten years.

#### 9. Document Imaging System Conversion Update-Andy Erdman

Erdman explained that the County is moving from Oracle to FileDirector for an imaging system. Annotations have presented issues for the conversion, but the hope is to have the conversion completed by the end of 2012.

10. Review of CU1488-07 for Donald Kerzner, W2768 CTH B, Town of Farmington Klotz explained the situation to date, noting the difficulty in identifying business storage versus personal storage. Molinaro asked whether a sum could be put into next year's budget for Corporation Counsel to hire a person on a one-time basis to work on the worst violations. Corporation Counsel will be contacted to consider future funding of legal assistance, as well as review and comment by legal staff of this particular petition.

# 11. Request for Outside Storage in the Ixonia Industrial Park at N8121 Industrial Drive by Volkmann Railroad Builders

The Town approved this request. The site is fenced, with a vegetated berm. Storage proposed is for vehicles, materials and equipment used by this company. Motion by Nass, seconded by Reese to approve the outside storage; motion carried on a voice vote with no objection.

The Committee proceeded to decision on R3619A-12, Evelyn Widmann Trust, c/o Bill Widmann, Town of Jefferson, part of agenda item 13.
