## **Program – Economic Development Part II: Financial Literacy Is Key to Economic Development**

Joel Thomas, the 2012 WI Governor's Council on Financial Literacy award winner, founder of the Financial Resiliency Foundation, and schools manager for EverFi, shared turn-key educational modules available through EverFi for teaching financial literacy to students. EverFi has certified over 4.5 million students across all 50 states in critical life skills such as financial literacy. EverFi provides 21st century financial literacy platforms to K-12 schools at no cost through private public partnership with banks and foundations. Joel spoke about the impact financial literacy has on economic development.
