1. Call to order

2. Roll call of Committee Members

Pete Weston spoke about his concerns with the Highway Facility RFP requirements Supervisor Christensen spoke in regards to the bidding process and Highway Facility RFP Edwin Bos discussed design/build projects that his firm has completed in the community

8. Discussion and possible action on the purchase of a Storage Area Network (SAN) by the MIS Department

Roland Welsch provided a resolution for the committee to review. He explained the necessity of purchasing of the Storage Area Network and addressed questions from the committee.

Motion made by Supervisor Jones; Second by Supervisor Schultz to forward a resolution to the County Board to accept the bid of Nimble Storage in the amount of \$96,128 for the purchase of a Storage Area Network including the fiscal note.-All (Motion Carried)

9. Discussion and possible action on the purchase of an Uninterruptable Power Supply(UPS) unit by the MIS Department

Roland Welsch provided a resolution for the committee to review. He discussed the purchase of the uninterruptable Power Supply (UPS) unit and addressed questions from the committee.

Motion made by Supervisor Kuhlman; Second by Supervisor Kutz to forward a resolution to the County Board to accept the bid of Quality Power Solutions in the amount of \$34,095 for the purchase of a uninterruptable power supply (UPS) Ayes.-All (Motion Carried) 10. Discussion and possible action on Community Supported Agriculture (CSA) County/City drop off site.

The committee discussed that plans to use the City as a drop off site is moving forward. No action taken.

11. Discussion and possible action on the final environmental inspection report for former Countryside Home

Phil Ristow talked about the final environmental inspection report. He has been in contact with the banks and attorneys involved to discuss this issue. He submitted estimates for the additional work that is needed to the bank and attorneys for their consideration. He is still waiting for a response from them regarding what concessions they are prepared to make. Phil also explained some options that the committee may have. The committee will discuss this again when the information is available. No action taken.

- 13. Discussion and possible action on Sheriff Annex Building construction project

Gary Petre provided a proposal from GMA Engineers to complete the Sheriff Annex Building construction project. Gary suggested that an RFP be issued for this project. Staff will issue the RFP and bring the information back to the Committee for their review.

Motion made by Supervisor Kuhlman; Second by Supervisor Schultz to issue a Request for Proposal (RFP) for the Sheriff's Annex Project. Ayes-All (Motion Carried).

14. Status report on the courthouse bathroom remodeling project

Phil Ristow explained that the contracts are signed and project is anticipated to begin April 1st. No action taken.

15. Discussion and possible action on advantages of construction management contracts

Supervisor Kuhlman provided information on the possible advantages of construction management contracts. He has had discussions with Dodge County and feels that this approach could save the County money. Committee and staff discussed their opinions on having a construction management contract. Bill Kern suggested that if the committee considers a construction manager they should be involved early in the design phase of the project. No action taken.

16. Discussion and possible action on proposals from architectural and engineering firms on the final site plan and building design for the Highway Department's new main facility Bill Kern provided a summary of the proposals that were received. Staff has started reviewing the proposals. He provided information to the committee on what approach they were using for conducting their reviews. He talked with Dodge County and other outside sources and they are willing to look at the

proposals and provide their perspective. The committee would like staff to review the proposals and bring their recommendations back to the Infrastructure and Highway Committees at a joint meeting. No action taken.

Motion made by Supervisor Kuhlman; Second by Supervisor Reese to authorize the Highway Commissioner and staff to review the proposals and bring their recommendations back to the committees for their review. Ayes-All (Motion Carried)

17. Discussion and possible action on a Request for Proposal (RFP) for final design of the Lake Mills and Concord new satellite facilities for the Highway Department Bill Kern provided a copy of the Request for Proposal (RFP) for final design of the Lake Mills and Concord satellite facilities. He went over the proposal and addressed questions and concerns from committee members. The Request for Proposal will be sent out today with a deadline date of April 5th.

Motion made by Supervisor Jones; Second by Supervisor Schultz to approve issuing the RFP with a change in the requirements to "Demonstrate building and site design expertise with a similar program or comparable to county highway or public work garages designed within the last ten years. Ayes-All (Motion Carried).
