8. Review and possible action on proposals from architectural and engineering firms on the final building design; site plan; and construction administration services for the Highway

Department's new main facility

Commissioner Kern reported Request for Proposals on the main Highway facility went out on February 20, 2013, and 13 proposals were received by the March 15, 2013 deadline. He stated that the Infrastructure Committee met on March 20, and from that point forward the 13 firms have been reviewed. He stated that the firms were ranked and awarded points based on experience of similar design work done by the firm, the design team currently on staff and their experience on large projects, and the overall management approach. Kern stated that in this ranking process he looked at the fees as a secondary item, feeling that qualifications and quality were most important in the design firm selection. He also stated that he and his Operations Manager, Brian Udovich, took the proposals to Dodge County Highway Department for their input and expertise.

The top six firms selected were: Mead & Hunt; Oertel Architects, Kodet Architectural Group; Barrientos Design; CBS Squared; and Angus Young.

Commissioner Kern gave an overview of the top six firms and previous projects completed. The Committees asked questions and addressed concerns regarding the Minnesota firms. The Committees then wanted to hear a report regarding the top six and their fees knowing that there is \$1.5 million in the County's General Fund and \$300,000 in the Highway budget available for a facility.

Kern reported: Barrientos Design \$613,999.00; Oertel Architects \$825,000.00; Kodet Architectural Group \$1,250,675.00; CBS Squared \$599,800.00; Mead & Hunt \$1.2 million; Angus Young \$735,500.00.

9. Review and possible action on proposals from architectural and engineering firms on the final building design; site plan; and construction administration services for the Highway Department's satellite facilities in Lake Mills and Concord

Commissioner Kern reported that 9 proposals were received with fees ranging from \$101,000 to \$270,000. Eight of the nine firms were the same firms as the main facility. The firms are still being reviewed for qualifications and will be reported on at the next meeting. The nine firms with proposals are: Kueny Architects; Venture Architects; General Engineering; Barrientos Design; Angus Young; Dorschner; Bray Architects; CBS Squared; Prairie Lights.

10. Status report on purchase of old Countryside Home property

Corporation Counsel, Phil Ristow, reported that we are still moving forward with the \$200,000.00 purchase price for the property. There was a negotiation with the bank regarding additional asbestos. The bank agreed to pay 50%, up to \$37,500.00, for additional clean up. Closing should be taking place on April 17, 2013.
