R3625A-13 & CU1729-13 – Joseph & Barbara Jones: Rezone PIN 022-0613-0644-013 (0.707 Acre) with conditional use to allow a tourist rooming house at **W9374 Ripley Road** in the Town of Oakland.

FROM AGRICULTURAL A-1 TO A-3, AGRICULTURAL/ RURAL RESIDENTIAL

R3626A-13 – Ernest & Karen Bankert: Rezone to create a one acre lot from part of PIN 006-0716-0914-000 (40 Acres). The site is at W1356 Homeview Road in the Town of Concord.

<u>R3627A-13 – Maria Cerroni Trust (LE):</u> Create a vacant 1-acre building site, and a 2-acre lot around the home at **N7073 CTH X** in the Town of Farmington from PIN 008-0715-0441-000 (45 Acres).
