- Coordinated Transportation Meeting The meeting was held at St. Coletta. Six people attended representing Brown Cab, St. Coletta, Bethesda, FISH and the ADRC. The 85.21 grant application was reviewed as well as the 2013 Coordinated Transportation Plan. Running, Inc., owner of Brown Taxi Cab is in the process of purchasing the taxi company in Watertown. St. Coletta is interested in coordinating training efforts with others.

The January meeting was canceled. The next meeting will be on February 3, 2015. Discussion may include review of 2014 statistical information, program updates, etc.
