- <u>CTH "W" (Near new Highway Facility)</u>

Progress: Most of the slope work and landscaping is complete. Will pulverize and pave the remaining section in mid-July.

• <u>CTH "N" (CTH B – CTH A) – 5.0 miles</u>

Progress: All slope work and landscaping is finished except last construction segment. There is approximately 0.2 miles of construction work to finish. We will complete paving work in August/September.
