Call to Order

The meeting was called to order by ICC Chair Russell Kottke at 9:30 a.m.

Pledge of Allegiance

Adoption of Agenda

Motion by Green Lake County, seconded by Jefferson County to approve the agenda.

Open Discussion of County Issues:

- **Green Lake County:** Jack Meyers had surgery but is doing well.
- **Jefferson County:** A large number of ICC members expressed an interest in touring the new Highway Shop after the meeting.

Dialogue Among County Officials: The Status of Transportation Planning in the ICC Counties

There was extensive dialogue around transportation issues. Comments from the ICC counties are captured below.

Jefferson

- Determining jurisdictional responsibilities is a need in Jefferson County, i.e. is there a need to make changes on who is the lead jurisdiction on various roadways? Need clarification and designation.
- Organizational Options: Should the main department remain as Highway Department or be expanded into a Transportation Department? Rural mass transit is an emerging need.

Dodge

- Has a Comprehensive Plan.
- Needs an updated Comprehensive Plan with a Transportation Element.
- Needs to address mobility and Human Services.
- Beaver Dam – does have a taxi.
- An older population is requiring expanded transportation options
- How do we define transportation?
- Rail: is an area that will be more important in Dodge County.

Jefferson

- Linkages to fiber-optics is a utility and/or community facility need.
- More people could work remotely if there was better broad band.

Columbia

- No additional Transportation Planning is likely in Columbia County.
- They do not have a County Administrator.
- The priority in Columbia County is a \$46 million building program.
- Some Departments are working on Transportation activities:
 - Bike trail facilities are becoming more important.
 - Highway projects
- There are needs for van transportation (ADRC helps).
- Agrees: need for high speed internet (and this is an economic development emphasis).

Green Lake

- Not moving forward with Transportation Planning.
- The County struggles to keep roads up.
- Not a lot of dollars.
- An aging County.
- In process of updating its Comprehensive Plan.
- The Town of Brooklyn did a 20 year road plan.

Jefferson

- Large ag operators are putting more pressure on local/town roads.
- Ag traffic is predominate in rural counties.
- It is important to balance economic development and transportation.

Green Lake

- Has two frac sand pits which are creating transportation issues.

Dodge

- Implements of Husbandry Law Implications: waste haulers are running very heaving equipment, but are not required to get permits like agriculture vehicles.

Jefferson

- Rail and emergency planning is another issue given the significant increases in shipping oil through Wisconsin.
- Chuck Morrone from the Strong Towns Program suggests an approach to transportation planning.

Green Lake

- Roads are falling apart because of a lack of funding.

Sauk County

- Just putting the Team together to do a Comprehensive Plan Update; this new plan will have a significant transportation element.
- Sauk County has the Parks function already in the Highway Department. Parks interests are a “step-child” to Highway interests. They should be separate departments.
- Doing a Placemaking Initiative: Sauk County envisions the Parks System enlarging with new additions to the system (being a part of Highway will no longer work.)
- Broadband is key to economic development. (If an area doesn’t have it, it will not have community development.)
- Sauk County is also concerned about the mobility of seniors and the underserved populations.

Jefferson

- Human Services/Workforce Transportation: There is a scenario of reaching out to St. Colletta’s to use their underused vans.
- See big difference between Highways and Parks; requires the right people.
- Pipelines – They have their own set of policies; it is important to look at the “land use element”.

Open Discussion of County Issues (Continued)

Jefferson

- The County has a Task Force on Operations and Organizations; what is Sauk County doing to review its organization?

Sauk

- The Sauk County organizational assessment process was summarized by their Board Chair.
- The County is doing a “mid-term assessment” of the County.
- They added a special board meeting at the end of April.
- Originally they ask supervisors to discuss what was accomplished in the past year, and what do they want to focus the budget on?
- The Sauk County detailed process includes:
 - In January, Supervisors are informed of the process
 - In March, Strategic issues are discussed in committees (3-5 year issues; 2 issues are identified per committee)
 - Issues are presented at the March Board meeting
 - In early April, there is an Intergovernmental Meeting: issues are discussed by Town, City, Village leaders. How do their issues relate to you?
 - On April 30, the only topic is to go over “Strategic Issues” (They come up with a new “grading system” and are trying to have a better scoring system).

Dodge

- April Board meeting: Supervisors will go on a “Bus tour” of parks and other facilities. This is a good for many of the new Supervisors.
- A Supervisor wants to do a “Forensic Study” of three departments; a kind of “Forensic Audit”; \$350 per hour to do this; would cost 6 figures to do this; may not get traction.
- They might rather do an in-depth audit of one department per year.

Columbia

- Audits (forensic) can be more of a witch-hunt rather than an audit; could be very demoralizing.

Adjournment

Motion by Dodge County to adjourn the meeting to a Tour of the New Jefferson County Highway Facility led by the County Administrator Wehmeier and County Board Chair Schroeder, seconded by Jefferson County at 11:30 a.m. Motion approved by voice vote. About 13 people participated in the tour.
