**Legislative Report given by David Callendar**

- The Governor signed the state budget and all the changes have taken place. The WCA reported that it was a good budget for counties because although there was no revenue growth there was also no reduction in funding.

**State Policy Changes**

- The prevailing wage has been repealed

- The State has prohibited increasing coroner fees to help fund indigent burials for the next two years.
- WCA budget summary will be posted on July 21, 2015
- Senate approved funds for the Milwaukee Bucks stadium
- The WCA fall session will focus on criminal justice issues and will include legislation related to opiate abuse

- Discussion led by Dodge County on the county allocation for library funding

### **Program Topic – County Leadership and Culture featuring Dan Hill, Specialist, UWEX Local Government Center and Sarah Schlosser, Executive Director, Leadership Wisconsin**

- Discussed and defined the leadership vs. management continuum
- According to the National Association of Counties (NaCo) Leadership Handbook (<http://www.naco.org/sites/default/files/documents/NACo%20County%20Leadership%20Handbook.pdf>) county leaders should focus on:
  - developing a vision and mission for the county,
  - engaging your board and your residents in the process;
  - fostering a spirit of risk-taking, innovation and entrepreneurship to support inevitable change;
  - working toward achieving consensus when deciding on important matters;
  - setting a personal example and ensuring that ethical behavior, policies and practices are in place throughout the offices and agencies of county government; and
  - learning to recognize and control stress and seeking a healthy balance in your personal as well as your professional life.
- Discussed and defined the four following motivational styles:
  1. Achievement. Individuals that are achievement oriented can be motivated by meeting goals and achieving outcomes.
  2. Recognition. Individuals that are recognition oriented can be motivated by celebrating success
  3. Power. Individuals that are power oriented can be motivated by having ownership in the process.
  4. Affiliation. Individuals that are affiliation oriented can be motivated by relationships, team work, and “being in the know”.
