MEETING MINUTES

- 1) Call to Order The meeting was called to order at 1:04 pm.
- 2) Roll Call Members Present: Kraig Biefeld, Nycol Haberman, Donna Haugom, Ted Tuchalski, Gail Scott, Sheriff Paul Milbrath, Paul Hable, Chief Vern Butzine, Ryan Leslie Others Present: Ian Lehrer
- 3) Certifications of Compliance with the Open Meetings Law In compliance.
- **4) Review of the Agenda** The agenda was reviewed; no changes made.
- 5) Citizen Comments There were no citizen comments.
- 6) Motion and Approval for August 10, 2016 Meeting Minutes Hable motioned to approve, second by Butzine all ayes
- 7) Communications None
- 8) Discussion on Natural Hazard Mitigation Plan Haugom indicated they were thinking about changing the All Natural Hazard Mitigation Plan to an All Hazard Mitigation Plan. The State only requires the mitigation plan to be natural hazards. Haugom checked with other EM Directors and decided to leave it as an All Natural Hazard Mitigation Plan.
- 9) Discussion on implementation of Integrated Public Alert & Warning System(IPAWS) Haugom explained that there was a small group that participated in training (Donna Haugom, Todd Lindert-Communication Supervisor, Denise Nyberg-Dispatcher and Carol Verhalen-Dispatcher). Haugom still needs to return information to AlertSense to create passcodes so that when messages are sent out the codes can be used to verify authenticity. Once that is completed IPAWS can be used if needed. Haugom expects it to be completed within a month. The committee questioned if the public can be made aware of the system. Haugom stated she will find out if a test message can be sent to make the public aware of the new system.

- **10**) **Discussion on Public Private Partnerships** Haugom stated that she is working with facilities, municipalities, non-profit organizations and first responders to provide information to each other of what resources they have available and how they can help each other during an incident. There was a meeting held 10/25/16. The meeting included discussions on Incident Command System, a speaker from a facility that had a fire, a speaker from WE Energies giving information on the process of re-connecting electricity and a speaker on Continuity of Operations. Haugom estimates the group will be meeting every quarter to provide training or hold exercises. Haugom received a grant to fund the Public Private Partnership Workshop.
- **11) Discussion on Public Information Events** Haugom wanted to let the committee know that the EM office attends Child Safety Fairs, National Night Out, Hispanic Fairs, Jefferson County Fair at these events the general public is given information on Emergency Planning Community Right to Know Act (EPCRA), evacuation/shelter-in-place and other family preparedness information.
- **12**) **Discussion on HAZMAT response at Nestle' Purina** Haugom stated that she and Ian Lehrer from Nestle' Purina met with Chief Ron Wagner (Jefferson FD) and Deputy Chief Todd Yandre (Lake Mills FD/Jefferson County HAZMAT). Lehrer stated that the meeting was held to discuss the facility's response to possible hazardous substance spills, fires and false alarms. Further discussion was had.
- 13) Discussion on Hazardous Materials Spills/Billings (08/11/16 to 11/01/16) Haugom stated that there was just one spill reported.
 - On 10/03/16 150 gallons of water and weed killer mixture equipment failure crack in 300 gallon tank causing about ½ of the mixture in the tank to be released SC Region Jefferson County, City of Whitewater, roadway E Lakeview Dr and S Waters Edge intersection, responsible party unknown.
