DRAIN 20

Magnoni and Hughes reported on the inspection of Drain 20 with all landowners present. This Drain will be cleaned beginning in September for one section which was requested by the landowners. The Drain Board discussed the current status of the culvert installation under Gopher Road. The Drain Board is awaiting Attorney Griggs' distribution of the landowners' assessment report.

The Drain Board acknowledged the Circuit Court Notice of Foreclosure in Drain 35.

The Drain Board discussed a current inspection of the water flow at Britzke Bridge. The rock buildup is very apparent due to low water flowage.
