<u>Board Members Present:</u> David Hughes, Ron Griebenow, Peter Magnoni, and Attorney Andrew Griggs <u>Landowners Present:</u> There were 11 landowners present whose names are listed on the attachment to these minutes.

Call to Order: Meeting was called to order by Chairman, David Hughes at 9:36 a.m.

Order of Business - Drain 44

Chairman Hughes introduced the Drain Board members and attorney. He stated the purpose of the meeting was to receive input from landowners regarding the cleanout of this drain.

Chairman Hughes further explained to the landowners that this drain had \$113.84 in its fund with outstanding bills of about \$1500.00 plus legal costs. He stated that an assessment would need to take place today either at a minimal level to pay current bills or at a level to improve the drain.

Ron Gribenow presented to the group the layout of the drain and the work that needed to be done. This drain is a tiled drain not an open ditch.

Attorney Griggs presented to the landowners that there are 96,984.70 benefited acres. An assessment to do the projected work with a 5% cash reserve would need an assessment totaling approximately \$60,000. He stated that a 60% assessment would raise \$58,190.82 – close enough to complete the work.

The landowners generally discussed various concerns, alternate approaches such as putting in additional tile, putting in an open ditch and abandoning the tile system. There was discussion about dissolving this drain. Attorney Griggs explained the procedure to dissolve the drain. The general concern was the vast amount of private tiling that was adding volume to the tiled ditch which can no longer handle the volume of water.

The landowners discussed the alternative of a minimal assessment just to pay bills and a 5% reserve. Attorney Griggs presented that a minimum assessment at 17% of benefited acres would be needed to pay minimum expenses. This assessment of 17% would raise \$16,457.00. Following discussion on the minimal assessment, Dean Jaeger made a motion to approve a minimal assessment to raise \$16,457.00. The motion was seconded by Brian Burtared. Chairman Hughes called for a show of hands vote. Results: 5 landowners for the motion.

3 landowners against the motion.

Based upon attendance, vote of the motion did carry, however, a question was raised that the number of acres benefited should determine if the vote carried. Chairman Hughes asked Attorney Griggs for precedent. Attorney Griggs said that the landowners would need to vote individually by benefited acres and one vote per property.

Attorney Griggs requested current photos illustrating the damage.

Chairman Hughes indicated that his last inquiry indicated the work had not been completed by Andy's Excavating. Chairman Hughes will follow-up on the progress with the drain.

DRAIN 14-C

Ron Griebenow reported to the Board that the culvert was installed and the work has been completed.

DRAIN 14-B

Ron Griebenow will meet with Tom Jaeckel to communicate landowner concerns before this Drain is cleaned.
