5. Overview of Open Meetings Law

Ward – state law, strict rules on when a committee can meet and discuss agenda/committee/public business.

Two important observations:

- a. As a member of a governmental body if an educational event invite is sent to the majority of the board/council and there is a connection to county business, attendance is permitted unless there is a quorum of any given. If a quorum of a committee was present, this would be in violation of open meetings law.
- b. Walking quorum is illegal. Two supervisors can talk business, however a third person cannot be spoken to about the same topic in another conversation by one of the first two. Phone conversations and emails fall under the definition of a walking quorum and are illegal.

Medical examiner contacted Morse – looking for a place to place the cremated remains indigent per-

sons who pass away. Dane County has constructed a crypt, is there a place in Jefferson County to place a crypt and could it be at/in Potters Field.

Jim Braughler – may be issues with placing in Potters Field, could be close to, but not inside of. Morse – other experts note that an inactive cemetery would need a permit and the crypt could not be placed on the site of an unmarked grave. Archeologist certification would have to take place.
