- Down Payment Plus Grant

 The Federal Home Loan Bank of Chicago has changed the way they are
 reimbursing counselors. To remain competitive in the market the counseling fee for the Down Payment Plus
 Grant has been lowered from \$700.00 to \$100.00 per closing.
- HBC Services, Inc. the former nonprofit agency that did the counseling for the HOME Consortium in Jefferson County has given JCEDC \$50,000 to be used to continue the program for residents of Jefferson County.
