Call to Order was made by Secretary Magnoni at 9:32 a.m.

Approval of Minutes

The Drain Board reviewed and approved the minutes of the May 9, 2019, Drain Board meeting.

Order of Business

DRAIN 36

Secretary Magnoni reported on the letter from Attorney Griggs listing various dates for meeting with the D.O.T. on site at Highway 16. The possible dates are June 19, 24, 27 or 28. Time is set for 9 a.m. to 3 p.m. on site.

DRAIN 44

Secretary Magnoni reported on the correspondence from Attorney Griggs regarding the bank loan. No action was taken.

Secretary Magnoni discussed the question of damage to Gopher Road. Ron Griebenow stated that the Town of Ixonia has requested that the road be repaired either by mud jacking or by opening the road.

Ron Griebenow requested that a letter be sent to Herr Drilling requesting that repair of the road be included as part of the original insurance claim.

Secretary Magnoni reported that a payment of \$4,000.00 has been sent to Kreuziger Drainage.

DRAIN 2

Secretary Magnoni reported that Fish Drainage has sent a Google Earth photo illustrating where they had done blow-out repair on this drain. Rom Griebenow requested a letter be sent to Fish Drainage requesting a list of materials used and a description of what actual work had been done on the four repair sites.

DRAIN 1

Landowners' representatives appeared before the Drain Board updating the board on what the landowners were discussing. Mr. Stoners' opinion was that Judge Brantmeier had ordered the Drain board to hold an additional landowners' public hearing. Neither Secretary Magnoni, Ron Griebenow, nor David Hughes remembered this order from

Judge Brantmeier. Secretary Magnoni is to secure a record of the court proceedings of the May 10, 2019 hearing to determine if this order was given. Magnoni will respond to Mr. Stoner concerning this issue. The future court date appears to be sometime in October, however, this is not confirmed.
