- 1. CALL TO ORDER was made by Chairman Hughes at 9:35 a.m.

- 8. REPORT OF DRAINS:

A. DRAIN 36

Attorney Griggs previously responded by email that John Marchewka, DOT's position is that the tile replacement may not improve drainage due to issues with the tile under the railroad. Mr. Marchewka also stated that the DOT would not do anything until the scheduled work on Highway 16 begins. The Drain board's position regarding the railroad issue is not in agreement with the DOT position. The Drain Board's present position is to wait until the Hwy 16 project begins.

B. DRAIN 15

Attorney Griggs communicated to the Drain board that high water prohibited the filming of the Britzke Bridge stream bottom. He indicated that Lake Mills Town Board has communicated that if the Drain Board gets three bids they will pay the entire cost of the lowest bid for the clean out. Attorney Griggs has requested an extension from the Circuit Court regarding this issue.

C. DRAIN 44

- 1. Attorney Griggs communicated that Adjuster Sarah Johnson is still in process of settlement offer. Attorney Griggs is recommending to file suit if we can not resolve this issue.
- 2. Attorney Griggs has sent correspondence indicating that Barton Chapman will be issuing the approval regarding the Application for Construction or Modification of this drain.

D. DRAIN 30

Chairman Hughes reported that the work on Drain 30 is now complete. The Drain Board approved payment for the work to Kutz Drainage.

E. DRAIN 33

Secretary Magnoni reported that Professional Vegetation Management did complete an inspection of the entire Drain 33. The results of the spraying done in August 2017 were that the drain was weed-clear, flowing at the appropriate speed and did not warrant additional spraying at this time. The one exception was the silt fill-in on the north side of the Battist property which was caused by erosion due to lack of berm on the ditch bank. This has caused week growth on the silt, however, at this point it has not caused restricted water flow.

9. PREVIOUS AGENDA ITEMS NEEDING FURTHER DISCUSSION

Secretary Magnoni reported that Robert Gilbert (telephone #920-261-6749) of Drain #20 called regarding a culvert problem. Ron Griebenow did go out to the site for an inspection. Ron indicated that he would meet again with Tom Jaeckel to review the issue and attempt to correct the problem.
