- 1. CALL TO ORDER was made by Chairman Hughes at 9:28 a.m. (via Zoom)
- 2. ROLL CALL: Board Members Present Hughes, Griebenow, and Magnoni,
- 3. APPROVAL OF AGENDA: The Board approved the agenda for October 12, 2020
- 4. CERTIFICATION OF COMPLIANCE: Agenda posted on County website
- 5. APPROVAL OF MINUTES: The Drain Board approved the minutes of the September 14, 2020 board meeting.
- <u>6. CORRESPONDENCE:</u> Marc DeVries to Cindy Diestelmann re Farm Drainage Board (copy attached)

The Drain Board was informed by Secretary Magnoni that Cindy Diestelmann, Finance Office, had hand delivered to him a written document from Marc DeVries, County Finance Director, addressed to Cindy Diestelmann, which included forwarding directions to the Farm Drainage Board. Said document is included as a part of these minutes and is attached to the minutes. The position of the Drain Board was complete surprise as no related information had previously been received from the Finance Committee. Secretary Magnoni also reported that neither the County Office of Planning or Zoning nor Land Information were informed of the Committee's action. The Drain Board discussed the State of Wisconsin's statutory mandates which this document's action would possibly violate. The Board then discussed the various drains in process or to be put in process due to crop out. These drains would suffer if this action of the Finance Committee did become effective after this very short notification period. The Drain Board referred this matter to legal counsel for guidance and direction. During this discussion period the Offices of Land Information and Planning and Zoning left a note for Board members to stop at the Land Information Office to further discuss the Finance Committee's action. ### A. DRAIN 15 MAIN

Secretary Magnoni reported that he had sent out three bid requests to three contractors, inviting them to update their previous bids to remove stones at Britzke Bridge. (All bid requests attached.) He reported that Contractor Krause Excavating did respond that their schedule was to busy to re-bid this project. Bids from contractors Velia Excavating and Jaeckel Brothers Inc. had not been received at the time of this meeting.

### **B. DRAIN 44**

- 1. Update on insurance claim information was not received at the time of the meeting.
- 2. The DATCP Application/Modification approval was not received at the time of this meeting.

#### C. DRAIN 20

The meeting to review the culvert problem was not held due to a scheduling problem with Contractor Jaeckel.

### D. DRAIN 33

Secretary Magnoni reported on the contact with landowner, Battist, regarding the annual inspection and opinion of Professional Vegetation Management. During this contact it was determined that no action would occur at this time.

Secretary Magnoni reported on the on-site meeting with Contractor Jaeckel regarding the trees and other issues with this Drain.
