Locast and Stafford talked about different bid package options. Stafford said that they would go to the County Board in September to approve the bids.

Phasing: Wehmeier shared some information on a tentative phasing plan.

Next steps: Locast explained that the schematic design is complete. Next step is the design development phase. Meetings will be set up with individual departments. They are starting to work on the structural design options. Design Engineers will be working on their plan and meeting with departments. A Kickoff Design meeting will be scheduled with the Team so that everything is

coordinated. The variance process with the City of Jefferson will begin in December. Site Plan approval with the City would follow. A security walkthrough with the jail is scheduled to discuss security upgrades. Locast has been meeting with code consultants to be sure we are meeting requirements in all areas.
