## 8. REPORT OF DRAINS:

#### A. DRAIN 14A

Ron Griebenow reported that during the month he had made several attempts to contact Tom Schadt, however, he was not able to make contact or get a return telephone call. This request is now considered closed for purposes of future action.

#### B. DRAIN 45

Ron Griebenow reported that contractor, Jaeckel, had completed the clean out of this drain. Ron was present during the clean out with various property owners.

#### C. DRAIN 32

The Drain Board was concerned that the assessment had not been sent to landowners by Attorney Griggs. During the February 2021 Landowners' Meeting it was reported to landowners that the assessment payment would be due 90 days after receipt of the assessment notice. This drain is scheduled for fall cleanout, however, we need to get the assessment out to the landowners or the payment period to accomplish the clean out will be missed. Ron Griebenow stated he would discuss this issue with Attorney Griggs.
