**OLD BUSINESS**

**8a. Discuss pedestrian crossing on US 18 (West of CTH Y)**

The City of Jefferson, Chief Pileggi, stated the crossing was under the Sheriff Department jurisdiction and that the lights were still there. There are no recommendations at this time from the City of Jefferson or WisDOT – Charlene Schmid. No Motion

**8b. Discuss speed zones on County Highway B**

Commissioner Kern stated that the Highway Department reviewed the data on the speed zone study near the CTH “B” and CTH “V” intersection. He stated that based on the study, no adjustment is needed at this time. It was moved by Witte, and seconded by Kern to accept the speed zones as posted. Motion Carried.

**8c. Discuss ATV/UTV use on highways and roads in Jefferson County**

The Committee had discussion regarding ATV/UTV use on the roadways in Jefferson County. The City of Jefferson stated they had three crashes and are putting a study together. The City of Lake Mills is issuing citations when vehicles are not riding in designated areas. No Motion.
