#### **TRAFFIC SAFETY COMMISSION MINUTES:**

#### **PUBLIC COMMENT:**

Peggy Stewart expressed continued concern about speed and truck traffic on STH 89. This was discussed further during Old Business.

Nicole Styles expressed her concern for pedestrian safety at the crosswalk near STH 18 and CTH Y. This was discussed further in New Business.

Laura Payne expressed her concern for excessive speed on STH 18 near Cambridge. This was discussed further in Old Business.

#### **OLD BUSINESS**

- a. Discussed speed concern on USH 18: Chris Wells said there is a safety project scheduled in 2027 & WisDOT to study (collect speed data & investigate speed limit reduction/improvements)
- b. Discussed speed and additional truck traffic (Kikkoman) concerns on STH 89. Peggy Stewart has list of trucks. Chris Wells is looking into potential options (truck route/speed study). Jake brake signs installed per Mike Hollinger, Jefferson Town Chair (semi issue, not dump trucks). Todd Horn mentioned State Patrol heavy vehicle inspection. Travis Maze said Sheriff speed board no longer works.
- c. The Traffic Safety website & Subcommittee outreach efforts were discussed. Elizabeth McGeary said no events are currently scheduled for the Subcommittee outreach, but e-mail was sent to school administrators; staff attended Jefferson Night Out and Lake Mills event.
- d. The commission discussed the 2024 Speed Awareness Day which was on July 31st.
- e. The commission discussed the 2024 Governor's Conference on Highway Safety which was held August 19<sup>th</sup>-21<sup>st</sup>.

#### **NEW BUSINESS**

- a. The commission discussed speed concerns on CTH B near Lake Mills and Concord. Traffic studies were conducted in multiple locations in both areas: compliance in Concord, but look at speed board and/or enforcement in Lake Mills (additional count to be done on east end).
- b. The commission discussed concerns for pedestrian safety at the crosswalk at STH 18 and CTH Y. Chris Wells will look into who permittee is (responsible for faded crosswalk) and options for increasing safety and awareness (beacon out of date/look at sidewalk extension on north side).
- c. The commission discussed the importance of local law enforcement/legal involvement in these meetings. They discussed ways to get the word out to increase participation/contact absent members.
- d. The commission discussed the possibility of municipalities installing Emergency Vehicle Preemption in their emergency vehicles. They noted the importance of compatibility of systems between nearby municipalities. Table issue and discuss with local Fire/Police/EMS.

# 10. Traffic Accident Spot Map – Jefferson County Sheriff's Department

The Spot Map was reviewed by the Committee (9 fatals this year -5 since last meeting). Travis Maze indicated wrong way driving on I-94 is a problem (7 in one night); has asked WisDOT to look at ramps at STH 89 (additional Do Not Enter signs, overhead lights, "light blockers" on barrier wall, etc.). No Motion.

Christopher Wells discussed numerous important dates, programs, and legislation related to DOT.
