Luckey and DeVries talked about using the Vested Benefit Reserve to help with succession planning. Luckey explained that succession planning was part of the Strategic Plan. This idea will be discussed by the Finance Committee at their next meeting. The Human Resources Committee supports this idea. **No action taken.**
