1. Call to Order

6. Approval of November 25, 2008 Administration & Rules Committee meeting minutes and the December 17, 2008 minutes from the joint meeting with Law Enforcement Emergency Management

The Committee discussed the National Recreation and Parks Association (NRPA) request to contact congressional leaders to support funding for local park construction and renovation. The Committee then asked staff to prepare a resolution for the January 13th County Board meeting that addresses the need for economic stimulus funding for county projects, including Parks, Highway, Courthouse Security Entrance, and any others.

9. Discussion and possible action on an election to fill the vacant County Board supervisor District 13 seat.

After discussion about the difficulty in recruiting for someone to fill the vacant District 13 Supervisor seat, the committee directed staff to prepare a resolution for the January 13th County board meeting, to authorize a special election in either February or April, 2009 (Corp Counsel to determine). Resolution to include the history of the prior attempts to fill the vacancy and accurate fiscal note of special election cost.

10. Update on the MIS Operational Audit

The County Administrator presented the Management Analyst's status report on the MIS Audit. No action taken, informational only.

11. Discussion regarding the Sheriff's Department Audit Preliminary Findings

The Committee, including the Sheriff and County Administrator, discussed the status of the Sheriff Department audit and the timeline for presenting the final audit report to the County Board. It is anticipated that this will occur at the County Board's February, 2009 meeting. No action taken, informational only.

12. Presentation by Dennis Smith regarding Strategic Planning

Mr. Dennis Smith, Strategic Business Services, presented to the Committee how Strategic Planning has evolved and the important role that it can play in preparing for the budget process. The Committee discussed the planning process and Mr. Smith responded to questions. Mr. Smith is available, pro bono, to assist the Committee in its future planning efforts. No action taken.
