Update of Fair Park Director Position: Terri Palm reported that they have received 41 applications and had done 5 interviews either in person or on the phone last week. - g) For 2008 don't have a theme room in the Conference Room may need part of the room for Fair Park Director's office
- h) Are we having a County wide Tent will check with Gary Petre
