Commissioner Kern reported that CTH "X" is currently being paved and will continue into next week, CTH "D" will be pulverized next week, and CTH "G" was pushed back due to delays on utilities. He mentioned that Town work was slim due to the costs associated with winter maintenance. The two positions discussed at the May meeting, Fleet Manager and Operations Manager, were discussed at the Human Resource Committee level and will be going to County Board in June. The Highway Department's sign department was discussed and committee questions were answered.
