

By June 2011 you were told 41,200 "preliminary" jobs had been created, although the actual number turned out to be 12,000. In the month of June you were told 14,800 jobs had been created and the actual number turned out to be zero. R – Juneau Watertown Daily Times March 17th 2012 In 2010 Wisconsin positive job growth started in February, one month before the nation started it's positive job growth. The average job growth in the first six months was 1,480 jobs a month and 3,550 jobs a month in the second six months. In 2010 28,200 private sector jobs were created

In 2011 12,000 jobs were created in the first three months of the year (up to when the budget was signed) Job gains for the year 12,800. 94% job growth occurred before the budget was signed. Before Governor Walker signed his "new budget" Wisconsin had been above the national average job number for nine months. Nine months after he signed the "new budget" Wisconsin was 51,820 jobs behind the national average. Since signing the budget Wisconsin lost 21,700 private sector jobs.

According to the Legislative Fiscal Bureau, the next state budget has a \$3 billion dollar deficit and the current state budget has a \$143 million dollar deficit. When you include the \$65 million minimum balance required by law this is over a \$200 million dollars deficit in the current state budget.


