
The Jefferson county Parks Dispartment hosted a playground fundraiser at Korth Tricklast Saturday.



## Inspired by 150-year-old oak, woman raising money for trees on Highway 26

#### TO GET A POSTER

A 24-by-30-inch poster showing the historic oak that once stood along Highway 26 north of Milton can be purchased at OurFavorite

Tree.com. Posters are \$10 each, plus \$10 for shipping and handling. Money from the poster sales will be used for planting trees along Highway 26.

Tracy Hegg, who took the photos for and designed the poster, has set up a Facebook page at facebook.com/OurFavoriteTree. The page allows people to share photos and stories about the bur oak, which was lost to highway construction.

Posters also will be delivered to the Rock County Parks Department, 3715 Newville Road, Janesville, today to be purchased without shipping and handling fees. Hegg said any posters purchased from Rock County will go directly into the Green Fund for Highway 26 bike-path improvements, including planting trees.

Posters also can be purchased at the Jefferson County Parks Department, Jefferson County Courthouse, 320 S. Main St., Jefferson. The money collected by Jefferson County will go into the Glacial River Trail Tree Fund.

MILTON — When Tracy Hegg moved from Denver to Milton more than a decade ago, she fell in love with the lush trees of her new home.

She also noticed every shady grove on her commute to work on Highway 26.

"That's when I first started driving by the tree," she said, referring to an especially stately 150-year-old bur oak that many motorists admired and loved.

The great oak with a massive crown spread of almost 100 feet inspired Tracy, a graphic designer.

"That's why I was so heartbroken," she said.

Workers removed the historic oak—and hundreds of other trees—last month to make room for the Highway 26 expansion north of the Rock County line. Emptiness now fills the wide space where trees once lined the road.

"It was very shocking," Tracy said. "It evoked a deep emotional response to see all those trees cut down."

Tracy said she is not angry about the highway construction, just sad to see the signature oak and so many other trees gone.

Out of her grief came an idea for replanting.

Tracy designed posters of the historic oak in four seasons and is selling them to raise money to put new trees along the highway. The \$10 poster is titled, "Our Favorite Tree," and reads: "Nature at its finest, you will be missed, 2013."

Tracy is working in cooperation with the Rock and Jefferson county parks departments.

"I printed 1,000 posters," she said. "We're hoping to sell all of them, which would raise close to \$10,000 because I need to pay sales tax."

In Rock County, the money will go into a special fund to make improvements to the new bike path along the highway, including the planting of trees.

"I think it's great anytime someone steps up with an idea like this," said Rock County Parks Director Lori Williams.

In Jefferson County, the money will go into a special tree fund.

"I think it's fantastic," said Jefferson County Parks Director Joe Nehmer. "We lost a tremendous amount of desirable trees, including several hundred nice bur oaks. We would like to replace them in the bike trail corridor as soon as the expansion project is complete."

A bike trail stretches along the highway north from Janesville and eventually will reach all the way to Highway 60 in Dodge County.

Nehmer called Tracy a "citizen leader who inspires us."

"People like Tracy build a better tomorrow," Nehmer said. "Her desire to create a more beautiful space will be successful. We have no way of replacing the signature oak, but we hope to create an area that is even more beautiful than it once was."

Tracy began photographing the oak in 2009 with the intention of using the photos in some kind of design project.

"I knew I wanted to take a picture of the tree the first time I saw it," she said.

She snapped her winter photo on a December morning after wet snow. Then, she made black and white prints and gave them away for Christmas.

The following year, she decided to take a photo of the old oak in every season.

"I wanted that bright green of new leaves in spring, but I didn't want the tree to be completely leafed out, "Tracy said. "I wanted to be able to see the unique characteristics of the branches with the new green."

Every day, she looked closely at the tree and waited for the buds to unfold.

"That bright green, just before it turns into a darker, richer green, is my favorite color," Tracy said.

She snapped her summer photo in late August, when the tree with its elegant symmetry of branches was completely leafed out. For autumn, she took a photo in early October, when all the leaves had turned a golden hue.

After Tracy designed and printed a poster in memory of the oak, she knew she wanted to share it with people who loved the tree as much as she.

"The decision to sell the poster was driven by a passion to keep the tree alive," she said. "It's a way to remember the beautiful tree. If it helps bring back trees for my children and future generations, I think it is well worth it."



# 2 Rivers Bike Club donates \$2,000 to improve south side bike trails

Improvements will be made to a portion of the Glacial River Trail as a result of funds raised by the 2 Rivers Bicycle Club.

The funds, which were presented via a \$2,000 check during Sunday's grand opening of the 2 Rivers Bike Shop in Watertown, will be used to help improve the trail's quality on the south side of the city near the intersection of High Road and Gateway Drive.

Scott Thomas, who is the co-owner of 2 Rivers Bicycle and Outdoor, said that improvements to the south end of the trail are extremely important.

"The south side of the trail is a weak link," Thomas said. There are no safe markings on the streets which presents a risk. Other communities have trails that are better marked.

Thomas said that another possible benefit to the improvement of the trails would be that more recognition may be gathered from the state, which in turn, could result in grants intended for biking and other recreational trails.

While the quality of the trail's south side does not pose as much of a threat to more experienced bikers, it does make travel more hazardous for less experienced bikers and larger groups because of narrower travel routes caused by onstreet parking and small road

shoulders.

"The primary motive of the improvements to the southern portion of the trail is to make biking and walking safer for families," Watertown Alderman Augie Tietz said. The area is especially dangerous for families during busier traffic hours because of the increased traffic and the deep ditches surrounding the road.

According to Tietz, the funds raised will be used for a request to eliminate on-street parking near the area of High Road and Gateway Drive and to establish better street markings. Tietz said that the estimated cost of the improvements will be \$3,500. In order to cover the cost difference between the estimate and the funds raised by the 2 Rivers Bicycle Club, Tietz suggested that excess city park and improvement funds might have to be used.

2 Rivers operational manager Lisa Bethard said that contributions from the public and local businesses would also be welcomed.

Beyond the changes being made to the trail near High Road and Gateway Drive, Tietz said that there are also plans to expand the trail into a part of the Watertown airport right of way that is currently not being used.

The process to expand the trail would require approval and could take one to two years to finalize.

## DNR is eyeing property owned by boating club



The Wisconsin Natural Resources Board will discuss the potential purchase of land currently owned by the Watertown Outboarders and used as its club grounds. The Department of Natural Resources' intent would be to use it as a public access recreational. The topic will be discussed at the DNR board's monthly meeting in Wausau next week.

The 6.13-acre property is located along the Rock River just south of Watertown and is adjacent to the Highway 26 bypass bridge. The purchase price of the property is reportedly \$174,000 and would require an estimated \$82,000 in improvements. The cost of the property would be covered by \$25,000 in contributions from Jefferson County Parks and \$149,000 in stewardship. Jefferson County Parks Director Joe Nehmer said the Earl and Eugenia Quirk Foundation of Watertown has committed \$25,000 to the project if it becomes a reality.



The property currently includes a concrete boat launch. several piers, a clubhouse, storage sheds and a gravel parking area. Keith Kuerschner, a Watertown Outboarders spokesman, said he was unable to comment on the proposal before the DNR at this time.

Nehmer believes the property would be a great addition as a river-based conservation property which would become part of the Glacial Heritage Area.

"The property is on a high quality stretch of the Rock River and is close to Watertown," Nehmer said. "Some of the best fishing on the river is on that stretch. It's also in great shape because the Watertown Outboarders have been great stewards of the land."

The purpose of the river-based conservation areas is to improve water quality, provide travel routes for wildlife and maintain and improve the current habitat.

According to Nehmer, other objectives for the improvement of the site would be to develop a property conducive to boat recreation, handicap accessible fishing, canoeing and kayaking. Nehmer said ideally the property would also possesses a number of camping sites located adjacent to or near the river.

The proposed property will not be intended for vehicles stopping through in search of a place to camp. Rather it would be intended for people who are traveling down the river.

"The plan is to maintain a very small footprint for the property," Nehmer said.

The Rock River has gained recognition as a quality recreational area. In April, the river was named a National Water Trail by the U.S. Department of the Interior, one of only 10 so designated nationally. The water trail covers 11 counties in Wisconsin and Illinois. The trail ends at the river's confluence at Rock Island, Ill.

## DNR OKs purchase of boat landing

Posted on June 27, 2013 by Jacob Meister The Wisconsin Natural Resources Board approved the purchase of land currently owned by the Watertown Outboarders in a 6-1 vote during their monthly meeting in Wausau. The only no vote was placed due to a board member's displeasure with the price per acre for the property.

Keith Kuerschner, a Watertown Outboarders spokesman, said the transaction cannot be completed without final approval from Gov. Scott Walker. Walker is expected to make a decision on the matter within the next month.



The 6.13-acre property has a reported purchase price of \$174,000 and is located along the Rock River just south of Watertown. It is also adjacent to the Highway 26 bypass.

The property presently possesses a concrete boat launch, multiple piers, a clubhouse, storage facilities and a gravel parking lot.

If the purchase is approved the property will likely undergo a multitude of changes. These changes may include a handicap accessible fishing area, numerous camping sites and an area for boat recreation, canoeing and kayaking. The improvements to the property have an estimated cost of \$82,000.

The Department of Natural Resources is expected to provide the facilities while Jefferson County will be

responsible for maintenance, according to Jefferson County board member Augie Tietz. Tietz also said the clubhouse will likely be torn down at some point if the DNR purchases the land.

While the property currently serves as the meeting place for the Wisconsin Outboarders, Kuerschner does not believe the club will disband if the property is sold to the DNR.

Tietz said the purchase would not be possible without the letters of support that were provided by various members and businesses throughout Watertown.

# Bike and Hike with the Artists at Korth and Pohlmann parks

If you have a yearning for art in the outdoors, hop on your bike or lace-up your boots for Bike and Hike with the Artists, June 29, between 11 a.m. and 3 p.m., at Korth and Pohlmann parks in Jefferson County.

The park events are free and family friendly.

Painters, potters, woodworkers, musicians, stained glass and fabric artists and photographers will set up displays, work on current projects, and answer your questions about their crafts during the day. The Department of Natural Resources also will have a wildlife display.

The event is sponsored jointly by the Friends of Glacial Heritage Area, the Arts Alliance of Greater Jefferson and the Arts Alliance of Lake Mills. Korth and Pohlmann parks are two of the dozens of recreation sites within the Glacial Heritage Area project.

"You don't have to bike or hike to mingle with and talk to the artists," said Mary Ann Jackson, Arts Alliance board member, "but for those looking to add a little exercise into the day can pedal the 14 miles between the two parks on the Glacial Drumlin State Trail.

"Hikers can drive between the parks and hike around the parks," she added. "Or, you could just pack a picnic lunch and join the fun that way! It's a fun day and a fun way to see this portion of the Glacial Heritage Area."

People planning on riding the Glacial Drumlin trail between Korth and Pohlmann parks can purchase their state trail pass at the Depot in Lake Mills. The Depot is alongside the trail in Lake Mills.

Annual trail passes cost \$20 and a single day-use pass is \$4. It does not impact this event but bikers are reminded that a por-

tion of the Glacial Drumlin trail just northwest of Deerfield, between Oak Park Road and Highway 73, is closed for maintenance.

The Glacial Heritage Area project is a coordinated series of parks, preserves, wildlife and natural areas, and other conservation lands in Jefferson County that are linked together, and to nearby cities and villages with different types of trails. This network provides readily accessible opportunities for residents and visitors to get outdoors to hike, bike, watch wildlife, fish, paddle, hunt, camp, cross country ski, ride horses, and participate in other nature-based activities.



## <u>ltinerary</u>:

- 1) Jump Right in: Single-Track Mountain Biking Trails at CamRock Area 3 on the west side of the Village of Rockdale. Address: 2334 Highland Rd., Cambridge, 53523. Check out miles of "more difficult" to "most difficult" trails with funky names like Rip N' Ride, Corkscrew, and Killer Klimb at Cam-Rock Area 3. Some trails are quite hilly and steep. Check out static and interactive maps at <a href="https://www.camrocksport.com">www.camrocksport.com</a> to set your particular route.
- 2) Ease into It: Double-Track to Single-Track From the trailhead in Cambridge, get on the smooth and flat CamRock Bike & Pedestrian Trail off County Hwy PQ (W. Water St.). A former rail bed, enjoy beautiful scenery through woods, wetlands, and prairie. The main trail connects to single-track mountain biking trails along the way. For more

- double-track, cross over the new bridge to more trails through woods and prairie at CamRock Area 2.
- 3) Food and Amenities in Cambridge When the biking's over, head north into Cambridge on the main CamRock Bike & Pedestrian Trail. Enjoy many restaurants, grocery, bakery, cafes, shops, and picnicking spots. Art and pottery galore! - 4) Hot Day? Take a Dip in the Lake Lake Ripley, a 420-acre lake in Jefferson County, is just a short bike ride down Cambridge's Main Street (Highway 12) heading east. For a swim, visit Ripley Park at N4310 Park Road. Enjoy large beach area, restrooms, changing area, playground, concessions, and picnic tables. Open 8 a.m. to 9 p.m. Daily admission fee is \$2 for adult, \$1 for children.

## Bike, Swim, and Explore Ancient Archeology: Glacial Drumlin Trail, Lake Mills, and Aztalan State Park

**Description:** Enjoy one of the finest, most scenic off-road bike trails in the state. The Glacial Drumlin Trail, an easy peddle on gravel and paved path, runs east-west across the GHA through woods, farm country, prairies, lakes, marsh, and picturesque villages. For this itinerary, hop on the trail either from the east in Sullivan or from the west in the Village of Deerfield. Enjoy Lake Mills with its many restaurants, swimming lake, and shops. Stop by Korth County Park (Lake Mills) for a picnic and restrooms. Next, visit Aztalan State Park, a National Historic Landmark and one of Wisconsin's most important archaeological sites. Aztalan was once the location an ancient Middle-Mississippian village between the years A.D. 1000 and 1300. The people built pyramidal mounds and a stockade around their village, which have been reconstructed for visitors.

## **Itinerary**:

1) Start East in Waukesha County, 17 Miles to Lake Mills Get on the Glacial Drumlin Trail at the trailhead in Sullivan (907 Front St., Sullivan, 53178). Ample parking facilities are available as well as food and beverage in Sullivan. A state trail pass station, restrooms, picnicking, and water are available at the trailhead. Trailhead is on Palmyra Street, south of Hwy 18. Along the way, stop in Helenville and Jefferson for restrooms, food, and beverage.

## Bike, Swim, and Explore Ancient Archeology: Glacial Drumlin Trail, Lake Mills, and Aztalan State Park

#### **Itinerary Continued:**

- 2) Start West in Dane County, 9 Miles to Lake Mills Get on the Glacial Drumlin Trail at the trailhead in Deerfield (212 N. Main St., Deerfield, 43431). Parking facilities, a state trail pass station, restrooms, picnicking, and water are at the trailhead. Food and beverage are available in Deerfield. Along the way, stop in London. Note: The Trail goes through Zeloski Marsh, important bird habitat with an interesting local history (see signs along the trail).
- 3) Swim and Lunch in Lake Mills Stop in beautiful Lake Mills with its many restaurants, shopping, grocery, art and pottery galleries. Take a swim in clear Rock Lake at Bartells Beach (free) located at Ferry Drive Lake Mills, 53551, or Sandy Beach Park (small daily fee) located at Sandy Beach Road Lake Mills, 53551. For details about Lake Mills, visit the Lake Mills Area Chamber of Commerce web site at <a href="https://www.lakemills.org">www.lakemills.org</a>.
- 4) Park Detour: Jefferson County's Korth Park Located on the west bank of Rock Lake just west of the City of Lake Mills, Korth County Park maintains pristine prairie and Oak Savannah restorations, abundant bird life, and spectacular views of the lake and surrounding areas. The perfect picnic spot. Picnic tables, shelters, and bathroom facilities are available. To access Korth from the Glacial Drumlin Trail, look for the Korth Park sign just west of crossing Rock Lake. Take the short peddle up a hill to get to the Park's south entrance.
- 5) Explore Ancient Culture at Aztalan Next, visit Aztalan State Park, one of Wisconsin's premier and most significant archeological sites. To get there on bike, take the Glacial Drumlin Trail east of Lake Mills (about two miles) to County Road Q north. Open year-round from 6 a.m. to 10 p.m., water, restrooms, and picnicking sites are available. While there, explore the ancient Middle-Mississippian village located along the banks of the Crawfish River. These ancient people built flat-topped pyramidal mounds and a stockade--sections of the stockade and two mounds have been rebuilt for visitors to explore. A State Parks sticker is required, available at the park.

## **Itineraries:**

### Trip 1: Rock Gardens, 10 Mile Paddle

**Features:** Enjoy the curvy upper Rock River Trail as you paddle through scenic rock gardens, shallow riffles, and many bends. Under low water conditions, some skill is required to maneuver through the small rock gardens and tight river bends. Where the Oconomowoc River joins the Trail, paddle around fish weirs. Look for nesting Bald Eagles along the way. Put in and take out numbers reference the GHA Watertrails Map.

**Trip Details:** Put in at Kanow County Park (PiTo 50) at N8238 Rock River Road, Ixonia. Fully-improved grassy launch, parking lot, shelter, restroom, picnic tables, grills, play area, and benches along the river available. NOTE: Kanow Park has been closed due to high water (check Jefferson County Parks for details). As an alternative, a gravel launch ramp is available one block south on Hwy 16 very near Kanow Park. **Take out at County Road Highway P** (PiTo 51) past Pipersville in Jefferson County. Rustic, grassy launch, located at the salt storage site on the south bank of the river. Roadside parking is available.

#### Trip 2: Hans Lake, 10 Mile Paddle

**Features:** Equally scenic, trip 2 takes you through Hahns Lake, a 72-acre lake near Grellton. The river bends that follow are narrow, densely wooded, wild, and peaceful. Look for nesting Bald Eagles. Two rustic PiTo's at either end make access a little more exciting. Put in and take out numbers reference the GHA Watertrails Map.

**Trip Details: Put in** at Riverview Road off County Hwy Y (PiTo 57), southwest of Watertown. A rustic, grassy launch, roadside parking is available. **Take out** at Resort Drive, North of Hwy 94 (PiTo 58) near Johnson Creek. This rustic, grassy launch is located on the east bank of river. Roadside parking is available.

#### Trip 3: Slow and Steady, 4.8 Mile Paddle

**Features:** Enjoy wide, open areas through scenic and relatively straight waters. Both PiTo's are easily accessible for first time paddlers. Put in and take out numbers reference the GHA Watertrails Map.

**Trip Details:** Put in at Rock River County Park, County Hwy B, Johnson Creek (PiTo 59). A fully-improved gravel launch located on the west bank. Parking, drinking water, restrooms, trash receptacles, grills, picnic tables, and shelters are available. **Take out** at Candice Street off Hwy 26,

Jefferson (PiTo 60). A semi-improved paved launch located on the east bank. Roadside parking and pier are available.

#### Trip 4: The Fort Finish, 7 Mile Paddle

**Features:** The river widens out and slows down. Enjoy mild rapids and explore a long island open to the public. Your trip ends in Fort Atkinson, a beautiful city with many restaurants, shops, parks, bakery, cafes, and more. Please visit the Fort Atkinson Chamber of Commerce to plan your stay: <a href="https://www.fortchamber.com">www.fortchamber.com</a>. Put in and take out numbers reference the GHA Watertrails Map.

**Trip Details: Put in** at 214 East Riverview Drive, Jefferson (PiTo 62). Jefferson' newly-paved launch is semi-improved on the south bank of the river. Riverview Drive is off of S. Wisconsin Drive in Jefferson. Roadside parking and trash receptacles are available. **Take out** at the Fort Atkinson Public Launch, N. Water Street West (PiTo 65). This semi-improved paved launch is located on the north bank. Parking and pier available and within walking distance to downtown city amenities.

## News Article: Rock River Water Trail Receives Exemplary National River Trail Designation



Water Trail

We are pleased to announce that the Rock River Water Trail has been designated a National River Trail, part of the distinctive National Water Trails System. Designated by the National Park Service this spring, the Rock River Water Trail is now connected to a national network of exemplary water trails throughout the United States.

#### Where is it?

The portion of the Trail within the Glacial Heritage Area runs from County Highway P in southeastern Dodge County through the communities of Watertown, Jefferson, and Fort Atkinson. The trail empties into the eastern edge Lake Koshonong in Jefferson County within the Koshonong Wildlife Area. The entire Rock River National Water Trail runs along the 320-mile river course from the headwaters in Fond du Lac County, WI to the Mississippi River at Rock Island, IL.

## What's the Significance of a National River Trail Designation?

The National River Trail designation will significantly advance efforts to connect the public to the Rock River Trail through conservation and restoration work for the benefit of outdoor recreation, the health of the Rock River and its shorelines, and surrounding communities.

Jefferson County Parks Director Joe Nehmer is optimistic about the benefits to local communities. "It means that we now have national exposure as being part of the National Water Trail System, and being within the National Park Service," he said. "We think, from an economic development standpoint, a tourism standpoint, a public health standpoint, and also a conservation standpoint, we're extremely fortunate."

You'll notice new National Parks Service logos alongside the trail this summer. "A number of us feel that that is our best strength, the fact that we're still a green area in southeastern Wisconsin, and really the last truly green area between Milwaukee and Madison. And now we have the good fortune of having a National Water Trail go right through our county," said Nehmer. "We've noticed, anecdotally, the paddlers on the river have increased the last several years. Needless to say, we expect that trend to continue with the National Water Trail designation."

## **EXECUTIVE SUMMARY**

The Jefferson County Parks Department has a history of planning for the future. This is the fifth comprehensive park plan that has been completed, with the most recent plan approved in 2005.

Jefferson County is a planning leader in Wisconsin. A public survey for the 1999 Agricultural Preservation and Land Use Plan indicated that most property owners wanted the County to retain its rural character, increase parkland, preserve farmland, and protect natural resources. Concentrating on what residents value has created energy for pursuing large conservation parks and linking trails.

The focus of Jefferson County's *Parks*, *Recreation and Open Space Plan* is to preserve natural resources while providing outdoor recreation. Creating a park and trail network like pearls on a string that also connects to cities, villages, and hamlets will benefit not only local residents but also draw visitors who want to experience nature, walk and bicycle on off-road trails, and visit local establishments.

This vision of a rural landscape with farmlands, woodlands, prairies, wetlands and glacial features interconnected with large conservation parks and a multi-use trail system is a model for retaining the separation between two large urban areas (Milwaukee and Madison), maintaining and improving natural areas, and enhancing an economy based on farming and agricultural businesses and industry and businesses in small towns. Several successful paddling and bicycling businesses have already sprung up and health care providers are enthusiastic partners in Jefferson County's park initiatives.

Planning is important to create a road map for realizing goals and objectives. The planning process does the following: it gives the public and stakeholders a voice, gives staff and consultants the chance to learn from others, studies current and future population, economic, and recreation trends, takes a fresh look at our natural resources, gives consideration and practical thought to expenditures and benefits, celebrates successes, and qualifies the County for a variety of grants.

Jefferson County is currently in the implementation phase of the 2005 Jefferson County Parks, Recreation and Open Space Plan and the Glacial Heritage Area plan. The plan is updated periodically to evaluate progress. Improvements to each park and trail over the last seven years were documented and new projects proposed. A capital improvement plan spanning the next five years was developed for each.

During the planning process the public was asked at three input meetings how they thought the implementation of the 2005 plan was going. Their response indicated that they appreciate the parks system, favor protection and improvement of natural areas, and want trail expansion. Several comments indicated excitement over the reconstruction of the Mason log home and farmstead master plan. Connecting parks to economic development strategies was also suggested. Several newspaper articles and radio spots informed citizens of upcoming meetings and planning activities. Meeting participants approved of the direction the Parks Department is going.

A new brochure was developed during the planning process that concisely summarizes the accomplishments of the 2005 plan, states the mission and visions of the Parks Department, lists priority projects, and provides a guide and map to Jefferson County Parks. The brochure is essentially an Executive Summary of the plan.





## **Project Background**

The cities of Watertown and Waterloo are located in Jefferson County and are situated just north of the Interstate 94 corridor, which links the cities of Madison and Milwaukee. Highway 19 runs east-west between Watertown and Waterloo, creating a secondary east-west corridor north of the interstate.

Jefferson County comprises the majority of land within Wisconsin's Glacial Heritage Area (GHA). This region is defined by gently rolling drumlin topography punctuated by wide rivers, teeming wetlands, and working farmsteads. Recreational opportunities are abundant in this region, and many cyclists travel through the GHA via the Glacial Drumlin State Trail located just south of Interstate 94.

Although there are large public land holdings between the cities of Waterloo and Watertown, it is challenging to connect these communities with the current trail infrastructure. A signed onroad bicycle route follows rural roads, but there are no off-road paths suitable for pedestrians, casual or commuter cyclists, small groups, children, or rollerbladers. Residents of both Watertown and Waterloo have expressed a strong desire to enhance connectivity between the two communities with an emphasis on increased safety for walkers, cyclists, and motorists.

The Jefferson County Parks Department engaged SmithGroupJJR as a planning consultant to develop a routing plan for a safe, off-road, multipurpose path to connect the two cities. The trail is an identified priority of the Jefferson County Bike Plan and the WDNR Glacial Heritage Area Plan.

### **Planning Process**

The planning process engaged the communities of Waterloo and Watertown in an open and transparent dialogue. The project team hosted numerous public meetings and solicited input from the steering committee members throughout the course of the project.

At the first steering committee meeting, the group identified potential stakeholders and defined the goals that would drive the planning process. With the continued input of the steering committee, the team then analyzed the potential connections between the two communities and identified the opportunities and constraints existing within the proposed trail corridor. (See the analysis and opportunities diagram, pages 6-7.)

The team hosted three public meetings with community stakeholders in order to gain feedback to inform the decision-making process. The first of these meetings was a public involvement kick-off meeting. During the second meeting, the team hosted a workshop/discussion in order to hear feedback on the three potential route alternatives. At the final public meeting, the team presented the preferred route and outlined potential funding strategies.

## INTRODUCTION

## **Existing Conditions**

There are a number of public destinations within the Watertown to Waterloo corridor. Perhaps the most promient is the Waterloo Wildlife Area, a publicly accessible 4,000-acre tract of land managed by the Wisconsin Department of Natural Resources. It is a regional destination for birders and hunters throughout the year. Trail development must be executed carefully in this area to prevent negative impacts to its ecology.


Holzhueter Farm Park is currently being developed as a new destination for mountain bikers and as a gathering place and outdoor amenity for county residents. It is located just west of the Crawfish River adjacent to the Waterloo Wildlife Area, north of Island Road.

Large private landholders in the Waterloo area include McKay Nursery and Trek Bicycle Corporation. Both parties have expressed interest in routing the trail adjacent to or through their property for the benefit of both the recreational and business communities. Knowlton Park in Waterloo is currently under construction and will serve as a trailhead to the Glacial Heritage Area (GHA) for the Waterloo region. The park is adjacent to the Trek Corporate Headquarters facility, and the improvements are the result of a partnership between Waterloo, Jefferson County, and Trek.

The scenic Crawfish River crosses the Watertown to Waterloo corridor about halfway between the two cities. It is a popular river for canoers and kayakers and is part of the GHA watertrails system. There are numerous public put-ins located along the Crawfish River and within the project study area. The Riverbend Resort, on the Crawfish River, is a private recreational destination within the corridor. The Rock River, which runs through downtown Watertown, is also popular for recreation and is part of the GHA watertrails system. There are numerous put-in points for the Rock River within the city of Watertown.

The stretch of land between the Crawfish River and the city of Watertown is home to many historic working farmsteads. Agriculture is a very important industry in this area, and it provides the backdrop for some breathtaking views of working farms in the glacial landscape. Opportunities for agri-tourism are abundant in this area.

## **Project Goals**

As part of the planning process, a set of guiding principles were established by the project team and the steering committee. These goals helped guide the trail routing process and include:

- 1. Improve Local and Regional Connectivity
  - Provide off-road bike/ped access between the cities of Waterloo and Watertown with connections to local amenities
  - Provide better bike/ped commuter access for Trek-employees
  - Connect to the existing regional trail network within the Glacial Heritage Area
  - Serve as a link in a system of trails spanning the state from the Mississippi River to Lake Michigan
- 2. Celebrate Natural and Cultural Heritage
  - Provide opportunities to view and experience public natural lands while minimizing negative human impacts
  - Provide opportunities to educate trail users about the ecology and geology of the Glacial Heritage Area
  - Provide opportunities to educate trail users about agriculture and land-based production in the Glacial Heritage Area
- 3. Provide Safe Recreational Opportunities to Trail Users
  - Keep pedestrians and cyclists out of high-traffic areas
  - Make the trail inviting and safe for riders of all skill levels and group sizes
  - · Maximize the functionality of the trail through the seasons
  - Encourage a healthy and active lifestyle for trail users and local residents
- 4. Create economic development opportunities in the region while minimizing construction and acquisition expenses
  - Utilize public land where feasible in order to minimize acquisition costs
  - Provide opportunities for new and existing businesses to serve hikers/riders
  - Leverage federal or state grant money to minimize negative impacts on the local tax base.

### **Routing Process**

In order to develop a final preferred routing scheme, the project team first explored a series of routing diagrams which were then distilled into three routing alternative plans. These options are shown on pages 10 and 11. The three routing plans were discussed among project team members as well as at both steering committee and public meetings. The team collected feedback from the community and used these comments to help shape the final "Preferred Routing Plan" as shown on pages 14 and 15.



- · Promote agri-tourism









### PREFERRED ROUTING PLAN

### **Proposed Trail Corridor**

The Preferred Routing Plan on pages 14 and 15 indicates the most desirable alignment for a future off-road recreational trail from Watertown to Waterloo. The solid burgundy line on the map is the primary route, while the dashed burgundy line represents future looping opportunities.

This alignment scheme reflects the ideas and feedback provided at the steering committee, stakeholder, and public meetings. The team also spent time in the field to verify the feasibility of the suggested route. In choosing this alignment, the team sought to complement and maximize the efforts and resources invested in the existing plans for the Glacial Heritage Area, Jefferson County Bicycle Trails, Watertown Parks and Recreation Trails, Waterloo Parks and Recreation Trails, and connections to facilities in surrounding counties.

Both the east and west ends of the trail are incorporated into the existing local trail networks. In some cases there is the ability to take the trail off-road, and in some cases the trail is routed along low-volume neighborhood streets.

The primary goal throughout the planning process was to keep the trail within the public right-of-way or on public lands. Residents and committee members also expressed a desire to locate the trail along road corridors with the lowest traffic volumes possible. There are some portions of the proposed routing scheme that suggest using private property for sections of the off-road trail. This would only occur as a result of voluntary public-private partnerships in the form of either acquisitions or easements. *No where* throughout the process was there any discussion or recommendation of aggressive condemnation as a method of acquiring land.

This plan is meant to be used for planning and funding purposes. This is not a design plan. As the process moves forward, more in-depth analysis and design resolution will be necessary. The public has been made aware that, as more detail is developed, there may be a need for grading and drainage easements adjacent to the trail. This study also acknowledges the need to integrate and properly design the trail to accommodate machinery access to farms and related agricultural fields.


The primary funding source will be public monies with the intention of avoiding negative impacts to local and community tax rates. Additional information on funding opportunities can be found on pages 22-26.







### Waterloo Routing


In developing a routing scheme for the town of Waterloo, the planning team wanted to explore opportunities for public-private partnerships with large land owners along the existing rail corridor, namely McKay Nursery and Trek Bicycle Corporation. The proposed routing also takes advantage of the quiet, low-traffic streets in the neighborhood south of Madison Street. From east to west, the signed on-road trail follows Pierce Street to Polk, then runs along Van Buren Street and Milwaukee Avenue. This portion of the trail interfaces with both county and local trails and provides access to downtown businesses, local parks, and nearby schools.

#### Waterloo Wildlife Area

The planning team encourages the community to route the trail through the Waterloo Wildlife Area because of the wide range of experiences this unique ecosystem can offer a recreational trail user. The wildlife area currently provides opportunities for year-round hunting, bird watching, and environmental education. A portion of the town's annual operational budget for the maintenance of this section of road could be used for the development of an off-road trail adjacent to the road. The planning team explored three options for integrating a recreational trail into this section of Island Road. These options are shown to the right.


A: 5' wide paved shoulders on both sides of the road

B: 10' wide off-road trail on one side of the road


C: Reconstruction of a new elevated road and trail

Jefferson County and the Town of Waterloo could easily implement Options A and B by using existing town road maintenance budgets and partnering with the Wisconsin Department of Natural Resources. 




Island Road Option A: 5' wide paved shoulders on both sides of the road


### **Watertown Routing**

The proposed trail enters Watertown from the west via West Street. From West Street, it briefly follows Milford Street, connects to W. Milwaukee Street, and finally links to Water Street to the north. From this point, trail users can access other local and county trails, downtown businesses, local parks, and schools via shared road networks. Future off-road opportunities exist along Milford Street and the proposed river trail corridor near the Bethesda Lutheran Home.

Additional areas of consideration include the Milford Street corridor, Horseshoe Road, and County Road Y. These roads connect the newly completed roundabouts and provide an additional southern access point from the proposed trail corridor west of Watertown to the existing Glacial River Trail leading south to Johnson Creek. (See future route option A).



### **IMPLEMENTATION**

#### **Funding Strategies**

The implementation of public amenities of this scale are often realized in phases based on the avialbility of public funding and private contributions. From its inception, this project has been intended to rely on federal, state, and county funding sources and not negatively impact the local tax base of the residents living within the trail corridor. Projects of this nature also often attract funding assistance from non-profits, corporate philanthropy, and private donations.

Many public funding programs do require local community matches. The percentage of local participation required varies from program to program. Local matches can include private contributions, services-in-kind, or capital improvements budgeted by local governments for new construction or maintenance.

The chart on page 23 outlines numerous programs that can be used to implement the proposed trail. Town leadership, County leadership, private businesses, and citizens need to collectively lobby and jointly apply for these public grants. State legislative representatives and key stakeholders should participate and provide letters of endorsement.

With everyone's participation, this project is acheivable. The end result will benefit the towns, the county, and private businesses. The development of this recreational resource will help to increase employment, increase economic investment, and improve quality of life throughout Jefferson County.

### **Recommended Funding Sources and Next Steps**

The next critical step in the process is to develop conceptual/preliminary planning documents that can be used in budgeting and future grant applications for the design and construction of the proposed trail. The typical funding source for these activities has been the WDOT TE and related funding sources. As of February 2, 2013, those funds will not be available or applications requested until early 2014. Funds will then be available for use by grant recipients in early 2015. The funds, including Safe Routes to School, are now being incorporated under the umbrella of the MAP 21 Federal Highway Bill and will likely be administered by the State through the Transportation Alternative Program.

Wisconsin EDC funds are not currently available for this project because the area encompassing the route does not meet EDC/HUD LMI requirements and would not likely meet EDC/HUD criteria for blight designation. Although EDC funding vehicles are not currently available, continued communication with the County's EDC Community Account Manager is strongly suggested should funding criteria change or new sources of funding become available in the future.

WDNR funds will be available for design and construction activities associated with the proposed trail. WDNR staff has recommended that an application for Stewardship funds, through the Acquisition and Development of Local Parks sub-program, be developed. This application needs to be fast-tracked to meet the May 1, 2013 deadline. The application could leverage existing funds including the Town of Waterloo road reconstruction funds. The application could fund design and construction (construction could take place in 2015 or 2016) of a segment of the trail including or adjacent to the scheduled road maintenance activities. This scenario would not allow for the design of the entire trail in 2013-2014 but would advance a phased completion and increase the chances of future grant requests as a continuation of an existing trail project. Multiple WDNR funding applications will be advanced over the course of the project and used as leverage/match for WDOT and other federally funded grant opportunities.

Given the current limited availability of funding sources to advance the project it is recommended that the County establish, at a minimum, quarterly meetings/conference calls with EDC, WDOT, WDNR, and Wisconsin Bicycle Federation representatives to keep abreast of future funding opportunities to continue the advance of the project. It is also recommended that the County and stakeholder units of government consider budget allocations for 2014-15 to have ready match funds for future grant applications/awards.

I am writing today on behalf of the Friends of Glacial Heritage Area, Inc. in support of the advancement of the Waterloo-Watertown bike trail project in the Glacial Heritage Area (GHA). After speaking with numerous residents from these communities, we believe there is substantial enthusiasm and support for the development of safe bike trails in the area.

As you know, our organization, the Friends of Glacial Heritage Area, Inc., has a database of over 300 supporters, representing residents, local businesses and non-profit groups interested in improving recreational opportunities and conservation activities in the GHA. We organize events and activities as well as volunteer our time at other community events throughout the GHA, which enables us to talk directly to residents about their recreational interests and concerns.

At several events this spring, we have talked extensively about the Waterloo-Watertown trail project, and the support has been overwhelming. On June 9<sup>th</sup> at the 2 Rivers Bicycle & Outdoor Grand Opening, many Watertown residents spoke passionately about the need for trails in the area, and everyone supported the prospect of an off-road trail that would be safe for children and families. (Many folks talked extensively about having nowhere to bike with their children.) We brought a map of the proposed trail route to these events, and we had people waiting in line to examine where the route may go. Folks also wanted to learn how they can safely access the Glacial River Trail from their community, and they were interested in learning about how trails inter-connect within the GHA.

At an event on June 29<sup>th</sup> at Korth County Park in Lake Mills, residents from Watertown in attendance were studying the Waterloo-Watertown proposed trail map, asking questions, and wondering when the project would be completed, again favoring the safer off-road trail option.

In light of this enthusiasm, we believe that this trail is a crucial development for improved quality-of-life in these communities, as well as a crucial step to attracting visitors to Waterloo and Watertown. Thank you and please contact us if you have any questions.
