To: Our Community Partners in Health

For some of you that don't know me I'm Chris Barron, Pharmacy Director at Fort HealthCare. I've had the pleasure of working with many of you over the years. Fort HealthCare has the mission to improve the health and well-being of our community and as such I have made it my mission to do our part to take on prescription drug abuse in the communities we serve. The methods at which we take on this issue are funding and participation in drug disposal efforts (Clean Sweep programs & secure drug drop-off sites) as well as participation in the Wisconsin Prescription Drug Monitoring Program (PDMP).

The purpose of this letter is to make you aware of existing efforts in the community to curb prescription drug abuse as well as ask for your participation in those efforts thru judicious prescribing practices and active use of the Wisconsin Prescription Drug Monitoring Program, as well as encouraging proper disposal of unwanted pharmaceuticals. It has been brought to my attention that not all area providers are aware of the PDMP or the wealth of information available thru the PDMP website.

Beginning January 1, 2013 Wisconsin implemented its PDMP. There are really two parts to the PDMP. The first part is the requirement that all dispensers of controlled substances (such as pharmacies) report those dispenses to the PDMP. The second part is the ability for pharmacies & providers to query the PDMP database for prescribing data. It is this second part where I ask for your participation.

The PDMP website <http://dsps.wi.gov/pdmp> is a wealth of information. I have included with this memo a sampling of free marketing materials available from the Department of Safety and Professional Services. More materials can be requested by emailing: PDMP@wisconsin.gov I encourage all area providers to make use of these free resources as well as get registered with the PDMP website so you can query the database.

Also included with this letter is a brochure for the Jefferson County Clean Sweep Program which lists the 2014 Clean Sweep events as well as the secure drug drop off locations. This brochure and related posters can be found at www.jeffersoncountyiwi.gov/cleansweep Lastly, I've included suggestions for all healthcare providers to consider when prescribing controlled substances.

While the websites listed above should be your primary sources of information I would be happy to answer any questions you may have regarding anything mentioned above. Together we can make a difference with prescription drug abuse.
