E-Waste Service Agreement

Universal Recycling Technologies ("URT") will provide Jefferson County ("Customer") with recycling services for electronic displays, peripherals, data containing equipment and other electronic materials (collectively referred to as "E-Waste") effective beginning May 18, 2015. The purpose of this agreement is to establish parameters for the collection and consolidation of E-Waste at Customer's facilities and transport to URT facilities for responsible recycling.

CUSTOMER OBLIGATIONS

- 1. Customer agrees it will provide a true and correct description of E-Waste collected, and that the E-Waste will conform to this description, including any material mix requirements identified in Addendum A Pricing. Materials that do not meet the mix requirements and/or Shipping & Packaging Guidelines (Attachment C) will be subject to additional handling fees. If the electronic wastes do not conform to the descriptions in this Agreement ("non-conforming material"), URT can, at its option, return it to Customer or require Customer to remove and dispose of the non-conforming material at Customers' expense, and reimburse URT for any expenses URT has incurred.
- 2. Customer acknowledges and agrees with pricing as stated on Addendum A Pricing.
- 3. Customer will package electronic wastes in such a manner as to comply with state and federal DOT regulations for proper packaging of E-Waste and to prevent breakage.
- 4. Customer shall sort and package E-waste materials in accordance with URT Packaging Guidelines, as defined in Addendum C, and make necessary arrangements to facilitate the collection and consolidation of electronic material in accordance to industry standards and practices and by mutual agreement of both parties.
- 5. Customer will contact URT and request a pickup or delivery date for all electronic waste shipments.
- 6. Customer will provide URT with reasonable access during normal business hours to the Customer's facility for the purposes of collecting for transport E-Waste.
- Customer shall coordinate all pick-ups and inbound loads with URT designated point of contact at least 5 business
 days prior to scheduled pick-up or drop off request. All pick-up and receiving acknowledgements are subject to
 schedule loading dynamics.

URT OBLIGATIONS

- 1. Handling of E-Waste Loads:
 - 1.1. When transportation is provided by URT, URT will transport electronic waste in a safe manner and in full compliance with all valid and applicable statutes, ordinances, orders, rules and regulations of federal, state and local governments in whose jurisdictions such activities are performed under this Agreement;
 - 1.2. URT shall respond to request(s) for pick-up transportation inquiries/requests from Customer within normal business hours of operation and accommodate pick-up requests in accordance to URT inbound scheduling dynamics.
 - 1.3. URT shall inspect the shipment prior to acceptance of an E-Waste load to confirm that the correct materials have been received.
 - 1.4. URT shall visually and manually screen each shipment for hazardous components. Notwithstanding any other terms in this Service Agreement, URT shall not accept any of the following materials for processing: liquids, chemicals, oils, radioactive devices, biological, infectious waste, dry powder substances or any materials not in conformance with universal waste rules and regulations.
- 2. Processing of E-Waste Loads:
 - 2.1. URT recycles all non-hazardous acceptable materials received or collected under this Services Agreement using standard methods approved in the industry.
 - 2.2. URT understands that some Customer equipment may contain electronic data which must be removed either through approved electronic data removal software or physically destroyed.

















- 2.3. URT ensures that all final wastes and hazardous materials resulting from the recycling process are disposed in accordance with all applicable laws, rules, regulations, orders, and ordinances, as they may be amended from time to time.
- 2.4. URT represents that all material shall be recycled and/or remarketed. "Recycled" means prior to resale or reuse all materials are (a) rendered unfit for their original use or (b) dismantled into component materials such as plastic, steel, aluminum and glass. "Remarketed" means the resale as a product or as an operating component of a product or reuse of the material for use as it was originally intended.
- 2.5. URT shall have the right to sell into global markets any commodities generated from E-Waste Materials. Any such sale by URT shall conform both to the export control laws and regulations of the United States and to the import laws of the receiving countries.
- 2.6. URT will provide electronic Certificates of Recycling and summary of all electronic wastes to contact provided by Customer in Addendum B Customer Details.

TERMS & CONDITIONS

- 1. Terms of Collection and Consolidation Services Agreement shall remain in place until **June 30, 2016** and shall continue in effect from year to year thereafter. URT will review pricing upon each pickup. However, URT or Customer may terminate this agreement with 60 day written notice at any time during the course of the agreement.
- 2. Weights and/or unit counts of electronic wastes will be determined upon receipt by URT.
- 3. Collector acknowledges that commodity values and fuel costs dramatically impact the ability to service the terms of this agreement and agrees to renegotiate in good faith if either fuel or commodities change by greater than 20%.
- 4. Both parties agree to assign a point of contact to conduct all ongoing communications and transactions.
- 5. Confidential Information: Confidential information shall include any information disclosed by one party to the other party in confidence; which shall be deemed the Confidential Information of each disclosing party and the terms of this Services Agreement, including without limitation, the fees charged or rebate payments paid by URT hereunder, which shall be deemed the Confidential Information of both parties.
- 6. Invoicing:
 - 6.1 Any invoices submitted by URT for services provided pursuant to this agreement are NET thirty (30) day terms. Invoices will be paid by check in accordance with written instructions provided by URT with said invoice. Any unpaid invoices beyond Net 75 shall be subject to a 5% late fee surcharge per month until such time as unpaid balances are paid in full.
 - 6.2 Any invoices submitted by Customer for services provided pursuant to this agreement will be paid NET forty-five (45) days from invoice date.
- 7. Fees: Amounts to be paid by URT or charges to Customer shall be as set forth on Addendum A.
- 8. Indemnification:
 - 8.1 Customer agrees to indemnify, defend and hold URT harmless from and against any and all liability (including reasonable attorney's fees) which URT may be responsible for or pay out as a result of bodily injuries (including death), property damage, or any violation or alleged violation of law, to the extent caused by Customer's use, storage or management of regulated or non-regulated electronic devices prior to URT's receipt of the same from Customer, specifically including but not limited to Customer's placement in or use of Hazardous Waste in boxes and pallets for the storage of regulated and non-regulated electronic devices.
 - 8.2 URT shall defend, indemnify and hold harmless Customer, its employees and agents against all claims by third parties (including legal fees and expenses) to the extent that such claims arise out of URT's negligent acts or omissions under this Agreement or failure to perform its obligations hereunder. URT shall promptly notify Customer of any claim. URT shall cooperate fully with Customer in the defense of any claim. This obligation to indemnify shall survive termination or expiration of this Agreement.
- 9. This Agreement will be governed by the Laws of the State of Wisconsin, and are binding on the successors and assigns of both parties. The indemnification made by each party will survive termination of this Agreement.



1. Call to Order

No meeting was called to order or business conducted on April 11, 2015 at 7:30 a.m. at the Jefferson County Fair Park, 503 N. Jackson Avenue, Jefferson, WI 53549

2. Roll Call (Establish a Quorum)

Committee members present were Don Reese, Kirk Lund, Carlton Zentner, Laura Payne and Ron Buchanan. There was a quorum of Committee members, but no action was taken.

3. Certification of Compliance with the Open Meetings Law

Sharon stated that the Solid Waste/Air Quality Committee complied with open meetings law requirements.

4. Review of Agenda

No changes.

5. Clean Sweep Event Operation

Veolia Project Manager Don Szymaszek conducted a safety meeting for all Committee members, staff, and volunteers at 7:30 a.m. He explained the safety procedures that need to be followed at a Clean Sweep event. After he was done, Sharon explained the jobs to the volunteers and Committee members; jobs then were assigned.

At 7:45 a.m. everything was in place and we started putting cars though the Clean Sweep. At this time we already had a business and three cars in line.

The results of our Clean Sweep event:

232 Jefferson County Clean Sweep Participants which included 2 Dodge County residents; 173 households, 19 farms, 5 businesses, 2 paint contractors plus 33 that were not surveyed. 13 residents participated in the tire recycling.

We had 3 residents from the City of Whitewater. The City of Whitewater will be billed for their 3 residents per our MOU agreement.

We had taken 213 appointments before the event. Eight residents and one business cancelled and we also had 10 no shows. That means we had 38 drive ups.

The 5 businesses were:
Norland at Swissray, Denise Rimmer
Palmyra-Eagle School District
Midwest Plastic Products, Jeff Fish
Humane Society of Jefferson County, Lisa Patefield
OSI Fort Atkinson, Sam Orvold

These county facilities used Clean Sweep: Jefferson County Fair Park Jefferson County Parks Jefferson County Highway Department

We received \$21 in donations.

The Sheriff said he took about 22 pounds of controlled drugs back to the evidence room.

The group sorted a pickup load of drugs from the Sheriff's Office plus what the Clean Sweep appointments brought in. 34 brought both meds and chemicals; 166 brought only chemicals.

We have not received the invoice from Veolia at this time so we don't know the cost or poundage of materials collected.

The tire collection was a success. We had 13 residents bring tires and we collected about 100 tires. I won't know how many tons were recycled until I receive the invoice from Liberty Tire.

Attached is the Survey work sheet.

A summary of the Latex Paint Collections:

The final count of raw recycled material TJM Innovations, LLC received was 2146 GCE (5 gallons=5 GCE, 1 gallon= 1 GCE, 1 quart= .25 GCE). Nora will let us know how much of the paint they collected will be usable or has to be dried out. She is hoping for 90% useable.

Mark said because TJM used Veolia's dumpster we had 3.44 ton of waste. At a normal Clean Sweep we have 1 to 1.5 ton of waste, so our waste cost will be higher. We also bulked more oil based paint. Mark was not sure of the percentage but estimated 30-40% more.

Veolia did all the unloading of the paint from cars and most of the separation of oil and latex, so our labor cost could be higher too.

Cars were backed up to the entrance. The most people had to wait was between 20-30 minutes. Veolia did a great job of keeping the cars moving. We had two phone calls complaining about the wait and three phone calls saying what a great service and event we held. Rob said one gentleman in line complained to him.

We will be discussing Clean Sweep at our next Solid Waste meeting June 19, 2015.

8. Adjourn

The Clean Sweep ended at 11:30 p.m. Veolia left the site at 3:00 p.m.

Dear Solid Waste/Air Quality Committee,

Thank you for contacting me regarding Governor Walker's proposal to cut funding for recycling and waste reduction programs, eliminating the UW Extension Solid & Hazardous Waste Education Center (SHWEC) and the UW Solid Waste Research program.

On Tuesday, the Joint Committee on Finance (JFC) accepted the Governor's proposal to cut an additional \$ 4 million from Municipal and County Recycling Grants. This cut will reduce the state's cost-share of local recycling programs to \$15 million in 2016. These long-term goal of the Republican majority is to eliminate all state funding for local recycling programs and allow those who are not self-sufficient to die on the vine.

The JFC set aside a decision regarding the elimination of SHWEC and the Solid Waste Research program and will discuss this at a later date.

It is very likely that the Republican majority on JFC has already earmarked the PECFA funding you suggested to be used for debt service, but have not let the Democratic members of the committee know what that purpose might be.

These programs have provided a great benefit to the state of Wisconsin and in many cases, have brought additional federal and private revenues for the state. Eliminating these programs makes little sense, but the Republicans in both houses have indicated that they are going to support many of the Governor's bad ideas in this budget.

It is not an exaggeration to say that the Governor's budget is a disaster for conservation efforts in Wisconsin. I will continue to work with my colleagues to make changes to the budget and restore funding for these important conservation programs. Unless there are significant changes to restore funding for these popular and essential conservation programs, I will not vote for the budget.
