1. Call to order

Tietz called the meeting to order at 9:02am

2. Roll call (establish a quorum)

Present: Matt Foelker, Augie Tietz, Steve Nass, Mike Kelly

Absent: Laura Payne

3. Certification of compliance with the Open Meetings Law

Meeting posted and in compliance.

4. Approval of the agenda

Nass motioned to approve the agenda. Kelly seconded. Motion passes on a 4/0 voice vote.

5. Approval of Park Committee minutes for June 7, 2016

Kelly motioned to approve. Foelker seconded. Motion passes on a 4/0 voice vote.

6. Communications

Communications were included in the packet.

7. Public comment (Members of the public who wish to address the Committee on specific agenda items must register their request at this time)

No public comment.

8. Discussion and Possible Action on US Bikeways Resolution

Nehmer – movement to designate the glacial drumlin trail as part of the US bike route system. Resolution intent to be sponsored by both Parks and Highway.

Nass motioned to approve the US Bikeways Resolution. Foelker seconded. Motion passes on a 4/0 voice vote.

9. Discussion and possible action to allow the installation of a return line for a well across county property to service a residence on Lamp Road

Ward – Homeowner on Lamp Road contacted the county. Homeowner wishes to install a well on parcel 41-20. In doing so, there needs to be a return line from the well to the Lake on or under County (Flood Mitigation) property. Referred the homeowner to the WiDNR on July 1, 2016 and have not yet heard back from the homeowner. Ward will also check the Flood Mitigation Property restrictions prior to any potential approval.

Nehmer noted concrete/asphalt and riprap that the homeowner would have to get through to access the lake.

Wiesmann noted wintertime activities and noted a return line would create soft ice at the boat access point.

Klotz suggested that the return line could also travel north and empty into/at the wetland parcel north of Lamp Road.

Klotz also noted that the homeowner would need Flood Plain Permitting and DNR Permitting for navigable waterways.

Ward will contact the DNR for more information.

10. Discussion and Possible Action on Pohlmann Park Silo

Nehmer – silo as part of Pohlmann farmstead. Improve parking for a better functioning lot with designated parking

areas. Survey shows that 2/3 of the silo is in the ROW (owned by County). Town of Jefferson had positive comments about silo retention. No official vote by the Town of Jefferson. The Jefferson County Historic Site Preservation Commission would like to retain the silo. No comments from the Wisconsin Historical Society at this time. Cornice at top is falling off, crack in silo, silo will probably stand another 100 years. Engineering study for safety is recommended.

Nass – received a few comments requesting the silo stay.

Foelker – if the costs are minimal, it can stay.

Nass motioned to conduct an engineering study for safety. Foelker seconded. Motion passes on a 4/0 vote.

Kelly – can we wait on study to spare expenses? Can cornice be removed?

Ward – noted his concern that parts of the cornice will fall off and injure someone.

Wiesmann – heavy rains wash out the parking area.

Tietz – conduct the engineering study and hold-off on any parking lot improvements.

11. Discussion and Possible Action on Illegal Activity at the Jefferson County Dog Park

Nehmer – noted there was a smash and grab in the parking lot. Prior to that, dog park attendant had broken window. Sheriff's department has increased their visibility and the parks department has posted signs at the park alerting park patrons to keep personal items from view in cars.

Tietz – noted the potential need to install security cameras in the future.

12. Discussion and Possible Action on Special Use Parks Permit Request at Dorothy Carnes Park July 7, 2017

Nimm have received a request to start a wedding ceremony at 8pm followed by a reception with permission to stay until midnight at Dorothy Carnes Park.

Nehmer – this is a quiet park.

Nass stated that the party shall vacate the park by 10 pm.

13. Discussion and Possible Action on Proposed Park Fees for 2017

Tietz questioned the camping fees and noted that we now have an annual campground inspection/licensing fee. Nimm asked the committee if they wished to implement Group Permit fees for groups greater than 100 people suggesting the department implement the shelter fees at 100ppl and more with attendance greater than 200ppl. With groups that large, the shelter is no longer available to other users.

Wiesmann noted that the committee also considers requiring traffic control/parking plan with large groups. Kelly – motioned to approve increasing camping fees at \$20/night and implementing a shelter rental policy/fee for groups over 100. Nass seconded. Motion passes on a 4/0 voice vote.

14. Discussion and Possible Action on Proposed 2017 Parks Budget

Nehmer – Capital Item requests were to replace a truck and mower, add a bike pedestrian counter, obtain a walk behind skid steer, Milford motors riverside access, and install curtain(s) to extend the season at Korth Park. Wehmeier – noted that \$.5m of requests were submitted versus what's available for funding.

Nass motioned to approve budget as presented. Foelker seconded. Motion passes on a 4/0 voice vote.

15. Parks Tour

The Parks Committee visited the following sites:

16. Adjourn

ORT ATKINSON — A walk along the historic, thickly wooded trails of Jefferson County's Dorothy Carnes Park at Rose Lake is a beautiful experience any time of year, but right now it's even more special with the inclusion of the Earth Art Lab.

The art project, according to a brochure available at the trailhead just off Carnes Park's Radloff Lane parking area, is "an intersection of creativity and nature inviting the viewer to think differently about their experience at Dorothy Carnes County Park in 2016."

Sculptures nestled along the three-quarter-mile "Art Loop" of the park's trails have been created from natural materials gathered locally and installed on-site. The pieces will be allowed to interact with the elements through October. Ten artists collaborated to bring six different installations to the trail.

Anne Drehfal is the artist who spearheaded the Earth Art Lab. Drehfal grew up in Nashotah but currently co-owns and runs the organic vegetable farm Regenerative Roots near Jefferson, adjacent to Carnes Park.

Drehfal took Family & Friends on a walking tour of the park's trails to describe and view each of the art pieces.


"I am the primary curator of Earth Art Lab and had an advisory council of friends, mostly from the Fort Arts Council, who helped sort through the artist applications with me and guide me in how to best approach our community/ county with this project," Drehfal said.

"My pieces are inspired by the simple, playful petroglyphs of the Southwest and the cacti that grow there," Debbink said. "It's interesting to me that humans have left their marks in sacred places. Blackened, like a burned out trunk of a tree struck by lightning, I finished my works by charring them."

he came up with Continued The idea of coordinating an art installation in Dorothy Carnes Park after seeing similar projects in northern Wisconsin at the Raven Trail near Woodruff and at the Farley Center for Peace and Justice in Verona.

"I loved how the art pieces changed my experience of art and of the forest at the same time, as well as how they evolved/decomposed over the seasons," she said.

As her tour of the park progressed, Drehfal came to her piece, "Willow Birdcages." She said she likes to think of the way her piece interacts with nature.

"It's kind of fun to think of birds sitting in them," she said of the three stylized, rustic wooden "cages" that hang from a tree branch in a small clearing along the trail. "And it's fun meeting walkers and seeing their reactions."

"Willow Birdcages" is a grouping of teardrop-shaped, willow sculptures. Drehfal's "primary art," in her words, is farming, so she is comfortable thinking about changing and designing a landscape on a fairly large scale.

"'Willow Birdcages' was the first time I had worked with willow and I had fun exploring how it preferred to shape itself into teardrop shapes while still green," she said, adding her more traditional mediums are photography and acrylic mono-printing.

"The park is home to many songbirds and I hope they will find comfort in these hanging pieces from time to time, allowing the visitor to question our relationship to the wildlife we share the space with, as we draw lines between nature and our world of technology and domestication," Drehfal wrote in the brochure for the project.

Drehfal said Carnes Park was chosen for the Earth Art Lab because it is close to her farm and she spends time there a few times weekly.

"For me, it was important that Earth Art Lab be at a popular place that folks visit and revisit frequently, so the artwork could be seen throughout the year under different weather conditions, seasons and lighting

angles," she said. "The trail I chose to be the 'Art Loop' has a lot of natural topography, beauty and diversity of ecosystems along it. It was important to me to feature the natural wonders of the forest and prairie there, as well as the art pieces, for visitors. It was a great place to work and it was fun to run into park visitors during installation periods and hear about people's excitement and curiosity about the project."

Prehfal said the county's parks department and its committee were incredibly cooperative and enthused about the project.

"The Jefferson County Parks
Department was very accommodating in approving the project after my presentations to them," she said. "Kevin Weismann, Jefferson County Parks supervisor, was very helpful on the grounds. All the art pieces were installed on time and our opening reception and Artist

"Community members were really enthusiastic and impressed by the caliber of the pieces."

Basic coordination of the project involved receiving approval for the idea from the Jefferson County Parks Department the past winter. A call was then put out to artists in the spring. Project coordinators reviewed and accepted applications, and artists were given one month of access to the park for installation of their pieces.

rtist Karen Gomez lives in Jefferson and said she was asked by several of her artist friends if she would like to participate in the Earth Art Lab.

"In collaboration with three fellow artists, we decided it would be a fun and enriching experience to create a sculpture in the woods," she said. "I am a collage artist. I work with handmade and found papers, sometimes incorporating natural and found objects. I am also a retired art teacher from Fort Atkinson and have worked on a variety of large collaborative projects with various artists, many of them sculptural."

Gomez has a bachelor of science degree from the University of Wisconsin-Stout in art education and a master of science from UW-Whitewater.

"The title of our piece is 'Unexpected Archway.' We discovered a natural arch formed by an oak tree right off the path," Gomez said. "A vine growing around the oak created a natural canopy. We initially tied a large grapevine to form the basic structure of the piece, creating 'windows' onto the landscape beyond. Next, we wove in milkweed stems, pear tree cuttings and finally tied on


smaller grapevine shapes and unexpected elements of stones, a wasp's nest, wool and feathers."

Gomez said this was her group's first experience working on "earth art."

"It was wonderful collaborating with other artists, as well as being limited to only natural materials," she said. "It was a great experience and I would love to do it again. We did run into rain and some warm temperatures, but as a whole, we had a wonderful time creating it."

Comez said her piece was created on the spot to change and move with the environment.

"It was not designed to be a permanent installation," she said. "I believe art enriches everyone. Creating and placing art in a location that interacts and enhances an environment benefits all who walk the path. It also brings more individuals to Dorothy Carnes Park who may not have taken the time to do so."

ontinuing the hike with Family & Friends, Drehfal said Gomez and her collaborators encountered some of nature's unexpected curve balls as they tried to establish their pieces in the thick woods adjacent to a well-defined turtle effigy mound created by ancient Native Americans. Just as creators of the Earth Art Lab discovered, ancient people who once inhabited the area also found the woods to be a wonderful outdoor art gallery a millennium ago.

Gomez said as they attempted to create their frame of a vista of Rose Lake, they did not know they were working in the midst of some of the most well-established and overwhelming poison ivy a person might find in Wisconsin. They were able to create the piece, however, without being too negatively affected by the irritating plant.


Drehfal said her pieces will likely be displayed on her farm when they are taken down from the park.

She said individuals and society as a whole benefit from earth art.

"I think the public benefits any time we are encouraged to look at the world through a slightly different lens than we are accustomed to," she said. "For art lovers used to studio and gallery contexts, they may see art differently if it is swaying in the wind or decomposing beyond the artist's control. For bird watchers or other nature lovers, they may view a tree differently if it is framed by a sculpture, or start to see the beauty of a spiderweb as art, as well. As an artist, I am excited to see how my work is changed by the elements and how the public reacts to it — and Earth Art Lab, as a whole — in this county park venue."

Participating artists volunteered their time and materials, and promotional items were funded mostly through individual contributions and the Fort Arts Council.

Drehfal said she loved Jefferson County upon her initial visits from Nashotah, but she grew to admire



it even more after getting to know the people who govern its parks.

"When I took the idea to the parks committee they were open to it and that just made me like this county that much more," she said. "The parks committee and parks department were so open and cooperative. They were awesome. I really hope this draws people to the park."

Jefferson County Parks Department Director Joe Nehmer told Family & Friends the department and its committee are grateful Drehfal approached them about doing the Earth Art Lab at Carnes Park.

"These types of partnerships are becoming more common in Wisconsin," Nehmer said. "This is our first experience with the concept. We have heard nothing but compliments about this particular exhibit. We feel it adds an additional element of enjoyment at the park. Nature, art, fresh air and exercise, it's all positive. Our hat is off to all the local artists that made this possible. We hope they will come back and do it again next year."

To Whom it May Concern:

My name is Mike Harrington and I own a company called The Disc Golf Experience. My main focus as a business is disc golf course development (design, installation, and consulting) as I am a Horticulturist and I spent 10 of my professional years in golf course management and the last 10 years owning a landscape maintenance company. I have the design background and a career in property management which is a huge asset when developing disc golf courses. A secondary role within my business is administration of leagues and tournaments not only at the courses I develop but wherever there may be a course that is heavily used and where a community of disc golfers can be formed to not only be social but also to help with fundraising and even the potential for some volunteer course maintenance.

I have been leading the volunteer efforts at Valley View Park in New Berlin for 6 years and with the help of a strong disc golf community we are able to accomplish a lot of maintenance and beautification that the city simply doesn't have the budget to handle. The city trusts me because of my background and my loyal following of disc golfers are always willing to help if it makes "their" course better.

I am currently working with the Village of Mukwonago to build a new course and re-design the existing 18 hole course down to 9 holes for safety reasons. I also know quite a few people in the general area and your new course in Palmyra has been a popular subject and a course that myself and many of my friends have visited multiple times. We have heard there was potential for the addition of more holes at some point but I understand the need to know the local demand. This is where I believe I can help.

I am requesting permission to test the waters by running a tournament at Carlin Weld this fall. Once we see how many are interested in competitive play you can decide if there is enough of a local following that could support a weekly league. This all would be valuable information to gather to help decide if further development of that park would be a worthwhile venture and/or if there may be another County Park that could handle an 18 hole course better.

What I am offering to do is help fund-raise during any tournament or league that I run at your park with the understanding that I do charge and profit from running these events. For example I have an arrangement with the City of Delafield that I do not have to pay any permit fees for selling merchandise or charging for league attendance but I also contribute money back to the City for course improvements which more than offsets the cost of the permit fees.

One big difference in allowing me to run these events is that I have access to the entire S.E. Wisconsin community of avid disc golfers as well as a national audience who follow me personally and my business on Facebook. I have built up a following of people because I have travelled all over the country and have played over 900 courses and met tons of people along the way. I have blogged about my travels in the past and I turned my Facebook page into a marketing tool to attract others who travel and play disc golf. While I will ask for your offices assistance in promoting to your local community members . . . I will pull most of the disc golfers from the avid community who generally frequent these types of events multiple weekends a year.

Projected Attendance, Building the local Disc Golf Community, and the Financial Agreement

I would expect to bring in at least 20 people but probably not more than 40 people for the first tournament. We are limited in the amount of attendees right now because of being only 9 holes which makes our capacity at 45 people. If the tournament goes well and we can get some more local support from people who may not have played in organized disc golf before then we could consider a weekly league. I would be happy to help establish this league with the help of a local but I wouldn't be able to attend every week because of my already busy schedule. Right now there really aren't any competing leagues in the area . . . in fact there really aren't that many courses within 20-30 minutes of Palmyra. That is why I believe that this is a perfect opportunity to try to start a new community of disc golfers centered around Carlin Weld Park.


Most of my leagues draw between 20-45 people per night and I typically run two sessions from Spring through Summer for a total of 20 weeks. Typically I have reserved \$1 per person at any event (tournament or league) I run and donate it to the municipality with the understanding that it is being used specifically for disc golf course improvements and/or future disc golf course development within the area. Between the leagues and a few tournaments we could raise anywhere from \$300-1000 per season if we are successful in building this local community of disc golfers. Not only will you have the funds to put to good use on the course but you will also have a very loyal group of locals who take pride and ownership in "their" course. They will help police for any vandalism or other negative activities. They will help pick up garbage on the course. They will help by removing fallen limbs from the fairways and tee areas. They will also be more than willing to help out on volunteer workdays if that is desired and allowed. They will be the first people to jump in and help out if you want to add more holes or make improvements to the existing course. Trust me . . . I have seen it work successfully on multiple courses now and want Carlin Weld to be the next community I help to build.

I am also willing to help establish an online presence on Facebook for the disc golf course at Carlin Weld that helps build community. People can post lost and found discs, they can post when they are going to play a casual round and want to meet up with new people, and it also doubles as a great place to find information about upcoming events.

I hope that you can see the value in working with someone like me who is so connected to the local disc golf community. I am willing to put in all of the legwork it takes to run these leagues and tournaments and I will do almost all of the legwork for promoting the events (although I would ask for some minor assistance in getting notifications in County publications, or listed at other county informational kiosks). Working together we should be able to make this a successful venture for both parties.

Please let me know if you have any questions or concerns and we can write up a formal agreement. If we come to an agreement we would be looking at finding a weekend without any local conflicting tournaments so that we can host this first tournament in September or Early October.

Deck Maintenance Recommendations

Consider removing some of the conveyor belts across the deck to allow the deck the ability to wash clean and dry quicker than the conveyor belts allow. Loose or missing connections to the edges of the conveyor belts should be reinstalled prior to use this coming winter.

Superstructure

The superstructure received an overall NBI rating of 8 and is considered in Good condition. There were no deficiencies noted on the superstructure. The superstructure consists of weathering steel and it is performing as expected. All connections and welds appeared to be in good condition.

At the time of the inspection, local fishermen were utilizing the structure to "dip" for fish. Their fishing gear was attached to the railing of the bridge but did not appear to cause any damage to the structure. From a bridge maintenance standpoint I do not have any concerns with them utilizing the structure in this manner.

Superstructure Maintenance Recommendations

At this time there are no maintenance recommendations for the superstructure. However, the County should consider a policy addressing fishing off of the structure as well as attaching hardware to the bridge railing.

Jefferson County Parks Committee

Dear Joe and Committee members,

Recently Joe and I talked about the paving and maintenance issues involved on the bike trail through Korth Park. We discussed the gravel base and the asphalt paved approaches. A citizen asked the Parks Department in a letter if those trails could all be paved with asphalt.

As a neighbor of the park, a biker and an elected official; I stated to Joe that I would rather see the renewal of the pavement on Korth Lane itself. I have always advocated for a shared improvement splitting the cost between the Town and the County. The road has been slowly degrading and is in pretty tough shape. It is rated a #3 on our Pacer rating scale. Korth Lane is .67 miles long and approx. 22 feet on average in width. There is one large culvert draining through the roadway.

I have gathered some very rough cost estimates from our Town engineer. I am assuming that if any engineering needs to be done to begin work, that that engineering work and oversight would be done by County Highway staff. Estimation of cost for milling, adding gravel and overlaying with asphalt will be between \$80,000-\$100,000. I have a more detailed estimate available and will forward that Park staff.

As we enter the budget time of year, I am suggesting that we begin to plan and discuss Park maintenance priorities and that you consider working together with the Highway Department and the Town to include this shared road improvement in both of our budgets for 2017.

I am available at any time to come to your next meeting and discuss this and other park related issues on behalf of the Town of Lake Mills.

Client has requested that Ziad Salameh LLC ("ZS") perform certain professional services at the project site, which services are set forth in greater detail in ZS's proposal (collectively, the "Services"). ZS and Client agree that the Services shall be performed subject to and in accordance with the following Terms and Conditions ("T&Cs"), and that Client's acceptance of ZS's proposal or its direction, whether oral or written, for ZS to commence any of the Services constitutes acceptance of these T&Cs.

- Independent Contractor. Approve County Conservation Aids Grant application

Executive Summary

The Wisconsin Department of Natural Resources Fish and Wildlife Management Grant Program was created to assist counties in the improvement of fish and wildlife resources. The fund was established by the Wisconsin Legislature in 1965 and provides matching money for a growing list of county sponsored fish and wildlife habitat projects.

The Jefferson County Parks Department is applying for financial assistance to remove invasive plants at the Garman Nature Preserve, Waterloo, WI. The 2016-17 allocations for County Conservation Aid (CCA) for the South Central Region have been set by the Wisconsin DNR. This year the allotment for **Jefferson County is \$1560.00**. State statute 23.09 (12), authorizes grants of matching funds to counties for projects focused on long-term fish and wildlife resources.

WHEREAS, the State of Wisconsin enacted legislation providing for allocation of funds to the respective counties on an acreage basis for county fish and game projects on the condition that the counties match the state allocation, and

WHEREAS, Jefferson County desires to participate in county fish and game projects pursuant to the provisions of s. 23.09(12) of the Wisconsin Statutes, and

NOW, THEREFORE, BE IT RESOLVED by the Jefferson County Board of Supervisors, that the Board is hereby authorized to expend the funds appropriated and the funds to be received from the State of Wisconsin for the improvement of fish and wildlife habitat, and to operate and maintain or to cause to be operated and maintained the projects for their intended purpose, and

BE IT FURTHER RESOLVED that the Jefferson County Board authorizes the Parks Director to act on behalf of Jefferson County to submit a state grant application to the Wisconsin Department of Natural Resources (DNR) for financial aid for county fish and game projects, sign documents, and take necessary action to undertake, direct and complete the approved projects.

BE IT FURTHER RESOLVED that the Jefferson County Board does hereby appropriate a matching allocation for such project and such appropriations shall continue as long as state matching aids are available, or until this resolution is modified by this Board.

Fiscal Note: The County's 2017 state allocation is \$1,560. Should additional funds become available, Jefferson County Parks will attempt to secure them. The County's match is force account labor to do the project. This year's project will focus on restoration around the entrance to the Garman Nature Preserve by removing invasive and non-native woody vegetation in order to promote the growth of native grasses and forbes. 



New trail signs planned in Milan

MILAN -- New signs are planned along the Rock River Trail, according to village administrator Steve Seiver.

"It's a pretty big deal," Mr. Seiver said, adding the signs will appear throughout the Rock River Trail up to Wisconsin.

"It's not only important from a recreational standpoint, but (it) also promotes local tourism," he said of the Rock River Trail and the signs.

In Milan, the signs will include mile markers, downtown information and trail labeling. Mr. Seiver said they should be in place sometime this fall. While the cost is not yet known, Mr. Seiver said it will be minimal for the village because of donations and the reuse of existing equipment.

Trustee Jim Flannery voiced concern about upkeep at the Hennepin Canal dam along the trail, noting that the weeds are overgrown "as tall as the ceiling." Mr. Seiver acknowledged the issue, saying local Department of Natural Resources workers are doing their best but don't have the resources needed from the state.

"They pay less attention to the west end of the canal," he said of the state, adding the only possible solutions he sees are to raise political pressure or help care for the area.

The rest of the area, he says, is well-cared for and popular with runners, bikers and walkers.

On Monday, the village board also:

- -- Discussed this year's Fourth of July run and fireworks. Trustees agreed it worked well to have both events the same day, but wondered how to handle events next year, when July 4 falls on a Monday.
- -- Learned from Mayor Duane Dawson that the Quad City Animal Welfare Center's new spay and neuter building in Milan officially has opened.
- -- Approved \$68,170.55 in semi-monthly and miscellanous bills and the treasurer's report citing \$285,759 in revenue for July.
