No action was taken. Item deferred to December meeting.




BEEN INCARCERATED WITHIN LAST 3 YEARS




REASON FOR INCARCERATION




DRUGS OR ALCOHOL RELATED




TYPE OF SUBSTANCE USED




UNDER INFLUENCE AT BOOKING




AGE PROFILE








WEAPONS USED








EMPLOYMENT STATUS






INCARCERATED WITHIN LAST 3 YEARS






DRUGS USED




DRUG TYPE




UNDER INFLUENCE AT BOOKING




AGE PROFILE




GENDER PROFILE


