Call to Order

The meeting was called to order at 2:00 p.m.

Review of the Agenda

The agenda was reviewed. A motion to approve it was made by O'Neil, seconded by Battenberg and passed unanimously.

Communications

Fritter reviewed the summary of the White House Conference on Aging, and an article 'Older Americans Act Appropriations: Providing Vital Support for Older Adults to Remain Living at Home' shared from the Wisconsin Aging Advocacy Network website.

Watertown Home Delivered Meals

Fritter discussed with the NPC that the Watertown Meal site began providing home delivered meals within the city of Watertown, both Jefferson and Dodge county residents, December 4th of 2017. Watertown began with 14 participants, and had since nearly double the amount of participants receiving meals to 25 for the month of January. Fritter stated that the site manager Patti had did a seamless job of integrating these new duties in her daily routine.

2018 Suggested Donation Rate

The suggested donation rate for 2018 was increased from \$3.75 to \$4.00 per meal, per discussion to increase rates incrementally by the NPC and ADRC Advisory Committee in 2015. Fritter shared that Home delivered meal participants and congregate participants were notified in advance of the increase.

Site manager Cheryl brought up that she had recently been grieving from a friend's suicide, and thought that I would be beneficial to learn more about depression and suicidal ideation signs and symptoms in the senior population. It was discussed that this would be a topic raised at a future NPC meeting.
