**10. Traffic Accident Spot Map – Jefferson County Sheriff’s Department**

Sheriff Milbrath discussed the multiple fatalities from last quarter.

The 2017 Rural & Urban Car Crashes in Jefferson County report showed the following:

Sheriff Department January 1 through December 31, 2017:

Rural: Fatalities 10; Number Killed 13; Number Injured 8; Injury Crashes 161; Number Injured 232; Property Damage Only 459; Car vs. Deer 404; Car vs. Deer with Injury 12; Number Injured Car vs. Deer 13; Car vs. Deer with Fatality 0; Number Killed Car vs. Deer 0.

Urban: Fatalities 0; Number Killed 0; Number Injured 0; Injury Crashes 134; Number Injured 167; Property Damage Only 644; Car vs. Deer 24; Car vs. Deer with Injury 0; Number Injured Car vs. Deer 0; Car vs. Deer with Fatality 0; Number Killed Car vs. Deer 0.

The 2018 Rural Car Crashes in Jefferson County report showed the following:

Sheriff Department January 1 through February 28, 2018: Fatalities 2; Personal Injury 21; Property Damage Only 125; Deer Crash with Fatality 0; Deer Crash with Injury 0; Deer Crash 51.

State Patrol January 1 through March 31, 2018: Fatalities 0; Personal Injury 5; Property Damage Only 19; Deer Crash with Fatality 0; Deer Crash with Injury 0; Deer Crash 2.
