Director's Report

- Amy Listle was appointed as Interim Director on April 21, 2019 with the intention to confirm appointment as Jefferson County Fair and Park Event Director at County Board on May 14, 2019.
- Submitted a Request to Fill the Marketing Specialist position with application review to begin May 17th.
- Submitted request with Human Resources Director to eliminate (2) part-time grounds workers and create (1) additional Maintenance Worker II position to go into effect in 2019.
- Accepted a donation from Jefferson County Pork Producers of \$925.55, earmarked for the swine barn project.
- Working on contracts for vendors, sponsors, entertainers, and advertising

Fair Park Supervisors Report May 2, 2019

Swine Barn

- Highway completed site prep before Car Show and put in ground cloth and drain tile between the buildings
