Jefferson County – Board of Health Meeting Minutes – July 17, 2019

Board Members

Call to Order: Conor Nelan, Vice-Chair, called the meeting to order at 1:00 p.m.

Roll Call/Establishment of a Quorum: Quorum established by Gail Scott, Director.

Certification of Compliance with the Open Meeting Law: Gail Scott, Director, certified compliance.

Board Members Present: Conor Nelan, Vice-Chair, Dick Schultz, Secretary, Maria Dabel, Samantha LaMuro

Board Member Absent: Don Williams, MD, excused prior to the meeting.

Members of the Public Present: Anita Martin, Lake Mills, regarding agenda item #8 – Public Comment

Staff Present: Gail Scott, Director, Elizabeth Chilsen, Public Health Program Manager, Tyler Kubicek, Environmental Health, Kaylie Wroblewski (Mason), Environmental Health, Elizabeth Alleman, Public Health Nurse, Sandee Schunk, Accountant II, Recorder

Approval of the Agenda: No changes requested.

Approval of Board of Health Minutes for January 16, 2019 Meeting: *A motion was made by Schultz/LaMuro to approve the January 16, 2019 meeting minutes. The motion passed 4-0.*

Review of April 17, 2019 Meeting Notes (No Quorum): Summary reviewed, no action needed.

Communications: Gail Scott, Director, introduced Elizabeth Chilsen, the new Public Health Program Manager and Elizabeth Alleman, the new Public Health RN. They gave the Board a report on their backgrounds and a round-table introduction was held.

Public Comment: Anita Martin, guest from Lake Mills, spoke on clean, safe water being a Public Health issue.

Review of Health Department Financial Report

- a. **Review and Discussion of Income Statement:** Sandee Schunk, Accountant II, reviewed the May 31, 2019 Statement of Revenue & Expenditures Report included in the meeting packet shows an estimated deficit of (\$20,236.32). The 2019 budgeted reserve funding available in the amount of \$158,723 will be used to offset any year-end deficit. The 2020 budget is in the initial entry stage.
- b. **Update and Possible Action on Women's Health/Family Planning & MCH Funding:** Gail Scott, Director, explained that the State applied for Title X funding that used to go to Planned Parenthood. Due to the lack of family planning services in Jefferson County, grant funding in the amounts of \$6,168 (for outreach to low-income pregnant women and referral for Medicaid benefits) was awarded. This grant period ended on 6/30/2019 - the short timeline did not allow it to be used – DHS Fiscal is aware of this. "Dual Protection Services" funding in the amount of \$12,000 was added to the existing State Consolidated Contract for Maternal Child Health Block Grant (MCH). This funding will be used in 2019 as long as Rock River Free Clinic's new Nurse Practitioner will be able to partner with the Health Department to provide these services. A meeting is set onsite for Monday, July 22nd with the State.
- c. **Review and Possible Action on United Way Pillar Grant, United Way Grant and Randy Schopen Grant**
Gail Scott, Director, reported on the United Way Pillar grant in the amount of \$2,000 that was awarded to defray the cost of having the Opiate/Heroin Awareness toolkits translated to Spanish. A United Way grant in the amount of \$2,500 is being used to purchase children's books for the TalkReadPlay program. A \$500 donation from the Randy Schopen Memorial Foundation is also designated to the TalkReadPlay Program for the purchase of books for children.
- d. **Review and Possible Action on Drug Free Communities Grant Budget/Staffing:** Gail Scott, Director, reviewed the information included in the meeting packet. Emi Reiner, Public Health Nurse and the head of the Jefferson County Drug-Free Coalition wrote and submitted the grant that focuses on youth prevention/education related to alcohol and drug abuse. The initial grant amount is \$125,000 and if

awarded can be requested annually for 5-10 years. The grant award notifications will be released in September. If the grant is awarded, Emi will be the main staff member working on the grant objectives and the Health Department may contract for an entry-level position to assist her.

A motion was made by Dabel/Schultz to approve the financial reports listed above. The motion passed 4-0.

Operational Update of the Environmental Health Program: Kaylie Wroblewski (Mason) and Tyler Kubicek, Environmental Health Specialists, updated the board on the Environmental Health program.

Discussion of Public Health Preparedness Program

- a. **Recent Exercises and Meetings:** Gail Scott, Director, reviewed the handout included in the meeting packet. Samantha LaMuro, Board of Health committee member, attended a free FEMA training on behalf of Fort HealthCare in Anniston, AL for 5 days of intense training. She reported it was a great experience.

Discussion of Public Health Program

- a. **Review of Statistics:** Elizabeth Chilsen, Public Health Program Manager, reviewed the report included in the meeting packet.
- b. **Review of Communicable Disease Cases Reported:** Elizabeth Chilsen, Public Health Program Manager, reviewed the report included in the meeting packet. A total of 29 communicable diseases were confirmed cases. Discussion followed on Planned Parenthood having only 6 facilities left in the state making a barrier for family planning services and Sexually Transmitted Infection (STI) testing.
- c. **Update on Executive Committee Discussion on Combining Boards/Committees:** Ben Wehmeier, County Administrator, reported that the combination of the Board of Health and Humans Services is not moving forward.
- d. **Dual Protection Services Update:** Gail Scott, Director, reviewed the handout included in the meeting packet. Health Department management and Katrina Wichlacz, Public Health RN, will be reviewing this check-off list with Rock River Free Clinic staff regarding providing emergency contraceptives, prevention of pregnancy, screenings by their new Nurse Practitioner and being able to meet the objectives of the MCH \$12,000 new grant funding addressed in agenda item 9b.
- e. **Community Dental Clinic and Rock River Free Clinic Updates:** Gail Scott, Director, reported that Dr. Rutledge at the Rock River Free Clinic is retiring in September 2019. Mary Beck-Metzger, Nurse Practitioner, will be taking over his role. Community Dental Clinic Director, Barb Gudgeon, will be retiring in December 2019. Fort HealthCare is writing a grant looking at organizing a Federally Qualified Health Center (FQHC). A FQHC facility can obtain funding from Medicare, Medicaid and health insurance. Clinic staff would be eligible for fringe benefits and tuition reimbursement. It would be a one-stop service clinic for eligible clients.
- f. **Staffing Update Health Department:** New staff members were introduced during Communications under Agenda item 7. Gail Scott, Director, reported that Elizabeth Alleman, new Public Health RN, will be helping at the jail on weekends when needed.
- g. **Update on Falls Prevention Program with EMS:** Gail Scott, Director, reported that this is in progress.
- h. **Review of Fort HealthCare/UW School of Pharmacy Opioid Stewardship Across the Care Continuum Grant:** Gail Scott, Director, reviewed the handout included in the meeting packet. The Health Department will work with the UW Madison School of Pharmacy and Fort HealthCare on provider education.

Discussion of Health Department Monthly Report: Gail Scott, Director, reviewed the 2019 monthly reports included in the meeting packet.

Future Agenda Items: Update on implementation of Women's Health/Family Planning grant, update on 2020 budget, possible Board of Health resolution regarding personal conviction waivers for immunizations. Please email Gail Scott any requested agenda items for the next meeting.

Adjourn: *A motion was made by Schultz/Dabel to adjourn the meeting at 2:35 p.m. The motion passed 4-0.*

Summary Highlights:

The 2020 budget provides \$857,526 in tax levy, which is a decrease of \$5,885 from the 2019 adopted budget.

The department plans to utilize fund balance of \$124,809 for operations.

In 2018 the Health Department had a balance of \$64,156 in unassigned fund balance below the 3-month goal in the Fund Balance Policy. In the 2020 budget the use of \$124,809 will bring that balance down below the 2-month requirement established by the Board of Supervisors.

WPHA and WALHDAB Support Medicaid Expansion

The Wisconsin Public Health Association (WPHA) and the Wisconsin Association of Local Health Departments and Boards (WALHDAB) believe all people deserve the opportunity to live in a state that creates conditions for everyone to be healthy. We also believe public policy should strive toward the elimination of health disparities which is why WPHA and WALHDAB support Governor Tony Evers' proposal to accept federal Medicaid Expansion dollars. Medicaid expansion will provide funding to support prevention initiatives that address social determinants and will provide health care coverage to more than 82,000 residents living between 100 and 138 percent of the federal poverty level. While WPHA and WALHDAB believe it is essential to provide healthcare coverage to the state's most vulnerable populations, we also support investing in a variety of programs, services and policies beyond healthcare that are essential to building a healthier Wisconsin.

According to DHS, the proposal generates \$324.5 million in savings which will be invested back into health initiatives focused on prevention. We can't afford to continue paying the high costs of treatment and care that accrue when we do not attend to prevention, including prevention related social determinants of health. Prevention saves lives and money. The WPHA and WALHDAB legislative priorities specifically focus on prevention opportunities related to justice reform, early childhood education, housing, and income stability and employment. Medicaid expansion provides an important first step in addressing these priorities.

Accepting federal Medicaid Expansion dollars allows the state to invest in a wide variety of prevention programs, related to both healthcare and social determinant of health, including the following:

Healthy Women, Healthy Babies Initiative

- Increase funding for the Women's Health Block Grant by \$1,935,600 to grant funds to entities that provide pregnancy testing; perinatal care coordination and follow-up; cervical cancer screening; sexually transmitted infection prevention, testing, treatment and follow-up; and general health screening.
- Expand postpartum services eligibility for women in the Medicaid program from 60 days to 12 months by providing \$22,988,000 in fiscal year 2020-21.
- Provide an additional \$1,012,500 in fiscal year 2019-20 and \$2,175,000 in fiscal year 2020-21 to expand home visiting to support expecting mothers and mothers with infants and small children.

Addressing Lead Poisoning

- Reduce the incidence of childhood lead poisoning in our state by providing \$24,996,000 in fiscal year 2019-20 and \$27,158,700 in fiscal year 2020-21 to increase testing, fund lead hazard abatement, and expand Birth to 3 services for lead poisoned children.

Dental Care

- Invest \$43 million to expand dental services for BadgerCare Plus and Medicaid recipients.

Community Health Benefit

- Invest \$45 million for nonmedical services to reduce and prevent health disparities that result from economic and social determinants of health.

Tobacco Cessation

- Provide \$3.3 million a year for tobacco cessation initiatives.

The state has the exciting opportunity to invest in programs that will have a significant impact for Wisconsin citizens by accepting federal Medicaid Expansion dollars. In fact, accepting Medicaid expansion funds is essential in order to be able to invest in these prevention initiatives more broadly. WPHA and WALHDAB urge the Wisconsin State Legislature to accept Governor Evers' proposal and invest in the health and wellbeing of Wisconsin's citizens. 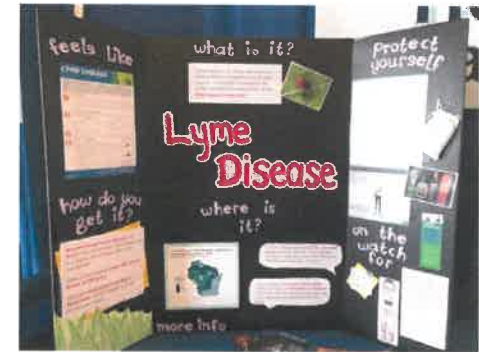

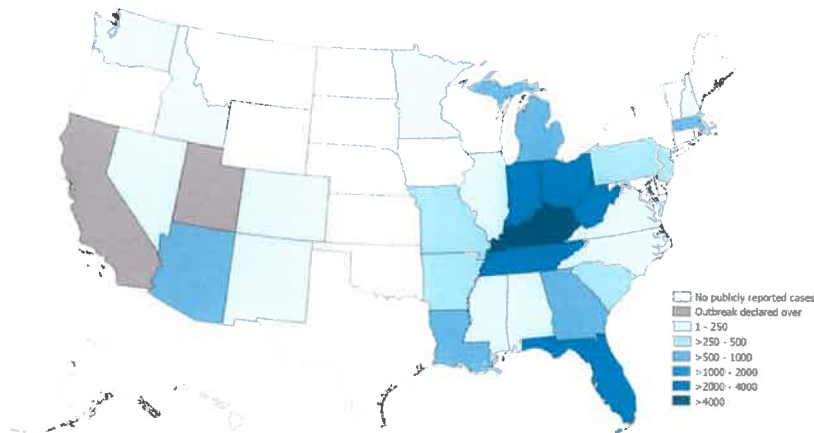
- Education went out to providers and Human Services regarding Hepatitis A and recommendations to vaccinate – especially the target population.

Currently in the U.S., multiple states are experiencing Hepatitis A outbreaks, including states surrounding Wisconsin (Illinois, Michigan, and now Minnesota). Hepatitis A is a virus that is transmitted through the fecal-oral route, and primarily affects the liver. For all age groups, 0.3-0.6% will die from contracting Hepatitis A, but that number rises to 2% for adults over 50. In August, public health emergencies were declared in Florida and Philadelphia.

Vaccinating inmates against Hepatitis A also protects the public at large. Food service is one of the fields in which inmates may find jobs after release. Since Hepatitis A can be transmitted through food through poor handwashing, vaccinating inmates may in turn help protect the public from future outbreaks. Jefferson County public health will continue having jail immunization events the 4th Friday of each month. Uninsured or underinsured individuals can also continue receiving their Hepatitis A vaccine (and many other vaccines) for \$10 at the Health Department on open clinic days (Tuesdays and Fridays, 8-4). No appointment needed.



Jefferson Kiwanis Donation

Many thanks (again) to Marv Moldenhauer for stopping in and providing Jefferson County Health Department with a \$500 check for our Kids' Safety Program. This money will be used to purchase car safety seats and educational materials. Thanks to Marv and the Jefferson Kiwanis!!



Drug Free Coalition Update by Emi Reiner, MPH, BSN, RN

The State Opioid Response (SOR) grant application was submitted for 2019-2020. This year, we hope to receive 1,600 drug deactivation kits because we expect the demand to be at least as high as last year (when we gave away 1,400). We are also going to support the medication disposal program, and we will be working with Brett Scherer of Clean Sweeps to organize 4 drug take back events targeting the senior population. Part of the medication disposal plan is to help reimburse law enforcement for their supplies and officer time to implement the program. The other two strategies that we highlighted in the application relate to community education and a public awareness campaign. The community education plan fits in well with our ongoing CHIPP to address substance use and the collaboration with Fort Healthcare on the Opioid Stewardship Project.

The Spanish translation for the Opiate and Heroin Awareness Toolkit is complete and it will be ready to print in a week or two. Both the English and Spanish toolkit will be available to download and print from the county web page. We printed 1,000 copies of the toolkit and almost 800 have been distributed, so we are anticipating another print run next year. I am currently writing the reflection and outcome reporting for the PHEP Opioid Mini-Grant.

Some fun facts about the prescription drug awareness campaign:

Five billboards ran for 4 to 11 weeks in various locations in Jefferson County

The estimated viewership of the billboards was 84,788.

Movie ads at the Johnson Creek Theatre played for 13 weeks and approximately 26,000 people viewed the ads.

Newspaper ads in the Daily Union and the Lake Mills Leader reached a total of 9,475 households.

We organized a Narcan (Naloxone) training to be held on September 22nd to recognize Heroin and Opioid Awareness Week. This event will be held at the Whitewater Library. The Walworth County Health Department will be providing a Hidden in Plain Sight Display. Also, to recognize Overdose Awareness Day on August 31st, we created a video on how to use Narcan, which was viewed by 1,398 people and shared 24 times (as of this writing). We are also planning other "how to" videos related to medication disposal, obtaining Narcan at the pharmacy, and using the toolkit.



WIC Update by Mary Wollet, RD

- Vicki G participated in the Johnson Creek Children's Fair, and participated in Jefferson's National Night Out. At both events, car seat technicians promoted and demonstrated child passenger safety to parents and caregivers.
- At the Public Health meeting on August 14, WIC created a breakfast for staff, using WIC approved foods to prepare the breakfast items. Other HD staff also brought foods to round out the offerings. We were celebrating Nutrition Day, part of WIC Enrollment Week, early. We wanted to honor our closest partners and supporters, Public Health staff!
- Jennifer took part in the Jefferson County Breastfeeding Coalition booth at the Fort Farmers Market. The booth was celebrating World Breastfeeding Week.
- Vicki G participated in the Governor's Conference.
- WIC Enrollment Week was August 19—23. Creative Marketing Resources, a company local WIC projects contract with, created #WICsconsin, and provided us with materials to celebrate every day of the week. Vicki created Facebook posts for each day. Jennifer worked with our partner, Jefferson County Breastfeeding Coalition, to get the word out. Mary distributed pushcards and flyers to clinics, libraries and Mary's Room.
- Mary, Jennifer and Elizabeth attended a Collective Leadership meeting at Watertown Center for Women's Health. This is a partnership between the state WIC office, Watertown Regional Medical Center, OB clinic staff, Jefferson and Dodge Counties WIC programs, and Watertown Department of Public Health. Collective was also represented by Amber France. We discussed barriers to breastfeeding and communication between stakeholders.
- WIC staff are in the process of viewing the New WIC Foods webinar, in preparation for the new food package in November.

Breastfeeding and Head Start Update by Jennifer Gaal

Here are some breastfeeding meetings I've attended this month in an effort to bring community partners together to collaborate ways to better support breastfeeding in our community.

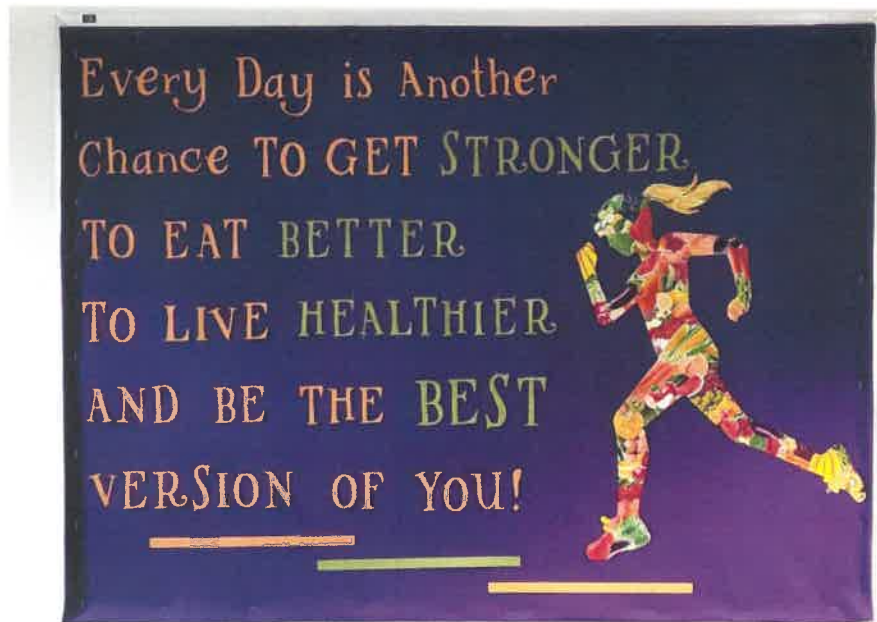
