DATCP REPORT Bureau of Land and Water Resources October 2019

Livestock Facility Siting

- The public comment period for the draft livestock siting rule, ATCP 51, closed on September 13th. DATCP received oral testimony from 162 individuals and 463 written comments. Staff gave an overview of the public comments to the DATCP Board at their September meeting. The final draft rule will be presented to the DATCP Board on November 7th.
- The Livestock Facility Siting Review Board will hold a business meeting on October 4th. DATCP staff will give an overview draft siting rule.

Producer-led watershed program

• DATCP received 30 applications for \$1,051,871.25 in funding requests through 2020 Producer-Led proposals. Funding decisions will hopefully be made by mid-October.

Soil and Water Resources Management Grants

- At their meeting on October 1st, the Land and Water Conservation Board will review and recommend approval of the final 2020 joint allocation plan.
- Transfers of 2019 SWRM cost-share funds must be completed by December 1, 2019.

Conservation Reserve Enhancement Program (CREP)

- Landowners receiving payment must use the most recent W-9 form (rev. October 2018) when completing CREP agreements. The WI Dept. of Administration notified DATCP in September that they will no longer accept older versions of the W-9. The new form is available <u>here</u>.¹
- The FSA deadline for finalizing the Federal CREP CRP-1 is September 30, 2019. LCD's should aim to complete the State-County CREP 15 year agreements (LWR-283) and submit to DATCP soon after that time to ensure the State CREP incentive payment is processed within the 2019 tax year.

Land and Water Conservation Board

• Douglas, Langlade, La Crosse, and Clark counties will present their county LWRM plan revisions to the board on Tuesday October 1st. Some of the other items on the agenda include: the 2020 Joint DATCP and DNR allocation plan, Livestock Facility Siting update, and a report on the 2018 program accomplishments.

Farmland Preservation Program

• A farmland preservation zoning ordinance for the town of Ithaca, Richland County was approved.

Staff Updates

• Wednesday Jordan is joining the Bureau of Land and Water Resources team as the Farmland Preservation Program Manager as of Monday, September 30th. Wednesday comes to us from the Winnebago County, Illinois Soil and Water Conservation District where she worked as the Resource Conservationist. Her work experience also includes time as a soil survey technician contracted for NRCS and was previously an intern in the Wood County Land and Water Conservation Department. Please join us in welcoming Wednesday to the team!

Wisconsin Farm Center provides assistance to farmers at no charge

Do you know any Wisconsin farm families needing advice about farm finances, farm succession planning, farm business entry or exit strategies, or other issues? The Wisconsin Farm Center, part of DATCP's Division of Agricultural Development, provides confidential assistance to farmers dealing with critical economic and business management issues.

As the downturn in the agricultural sector lengthens, the Farm Center has seen an increase in stress levels among farmers. Dairy currently tops the type of farm calling the Farm Center Helpline, with a majority of callers concerned about finances. Stress is a major underlying factor, and Farm Center staff regularly gauge a caller's need for counseling vouchers, which are provided at no cost.

The Farm Center works one-on-one on issues ranging from financial consulting and succession planning to assisting farmers with herd health or specialty crop questions. There is no charge to utilize any of the Farm Center's services.

Land and Water Resource Management Plan 2020 Update – Summary of Process

Wisconsin law requires each county to have a land and water resource management plan that has been approved by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP). The plan enables the county to receive both staffing funds and funds to cost-share conservation practices with landowners.

Plans are approved for a 10-year period, with a review by the board in year 5. Jefferson County's 2020 plan update is scheduled to be considered by the Land and Water Conservation Board at their October 2020 meeting.
